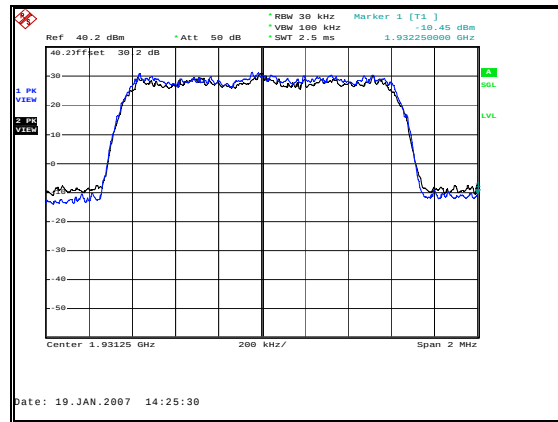


Figure 1: Occupied Bandwidth - Downlink CDMA Low Channel

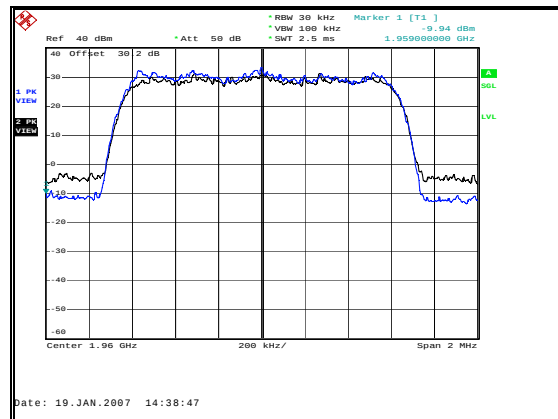


Figure 2: Occupied Bandwidth - Downlink CDMA Mid Channel

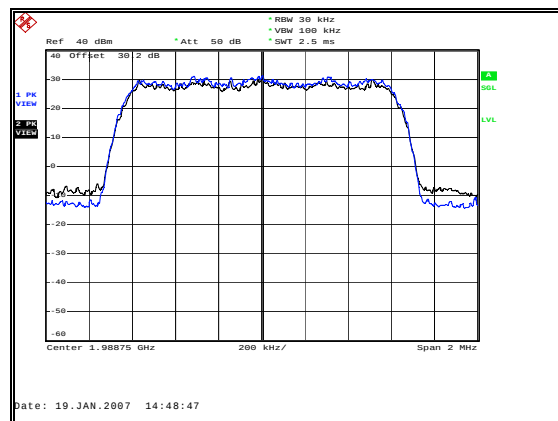


Figure 3: Occupied Bandwidth - Downlink CDMA High Channel

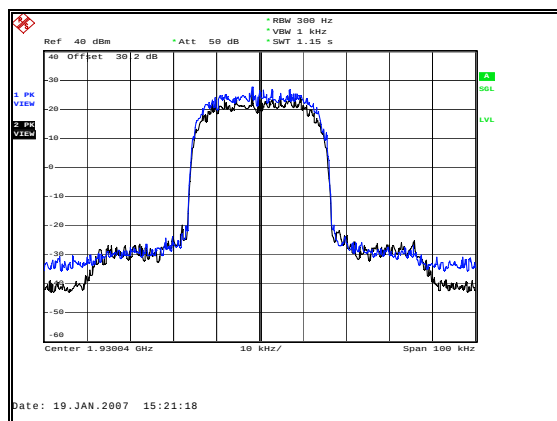


Figure 4: Occupied Bandwidth - Downlink TDMA Low Channel

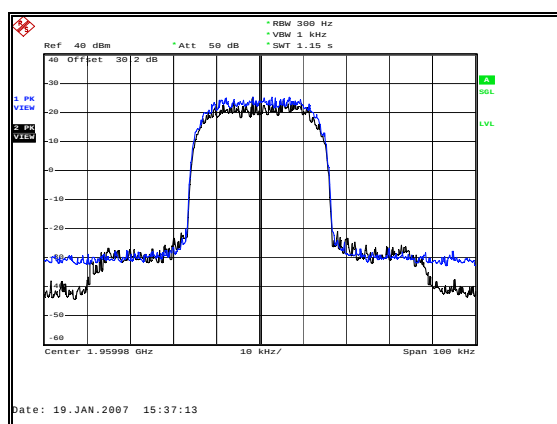


Figure 5: Occupied Bandwidth - Downlink TDMA Mid Channel

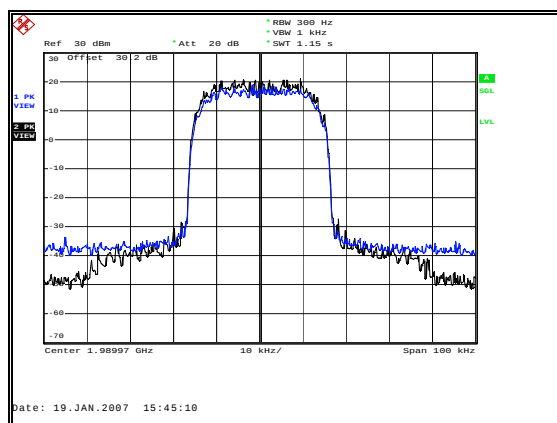


Figure 6: Occupied Bandwidth - Downlink TDMA High Channel

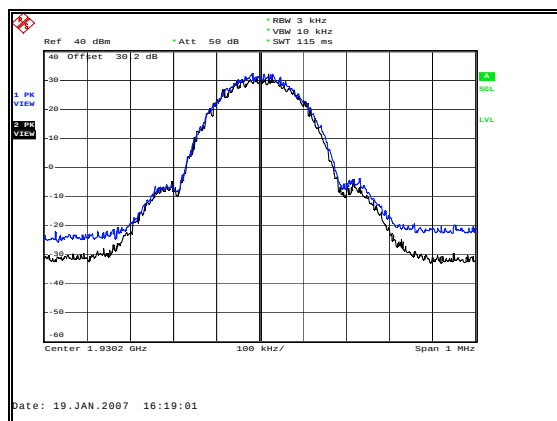


Figure 7: Occupied Bandwidth - Downlink GSM Low Channel

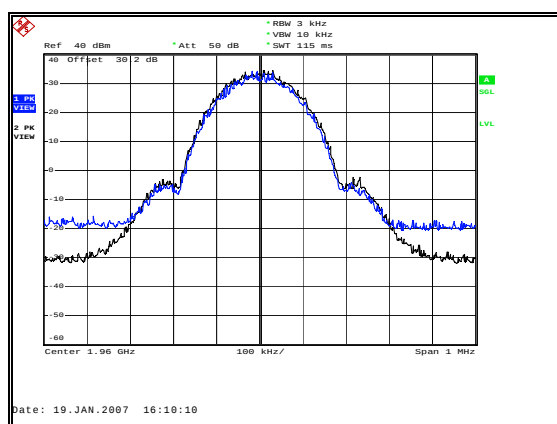


Figure 8: Occupied Bandwidth - Downlink GSM Mid Channel

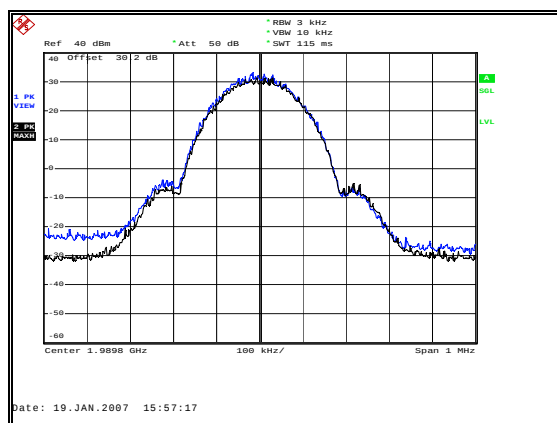


Figure 9: Occupied Bandwidth - Downlink GSM High Channel

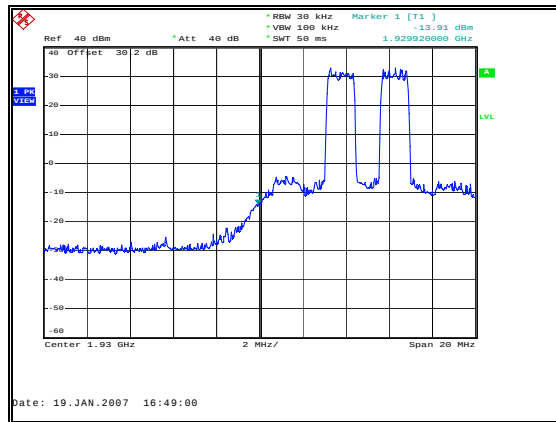


Figure 10: Spurious Emissions - Downlink CDMA Low Channel – Inter-modulation In Band

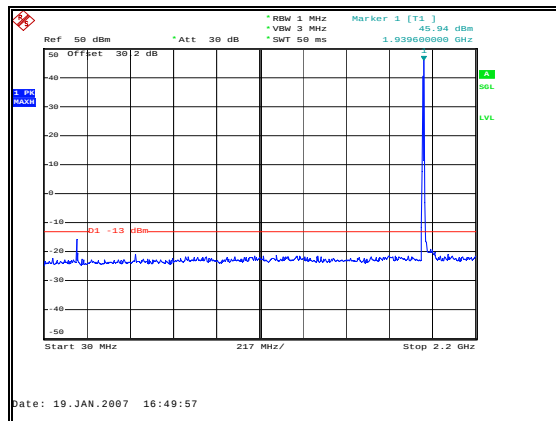


Figure 11: Spurious Emissions - Downlink CDMA Low Channel – Inter-modulation-30MHz to 2.2GHz

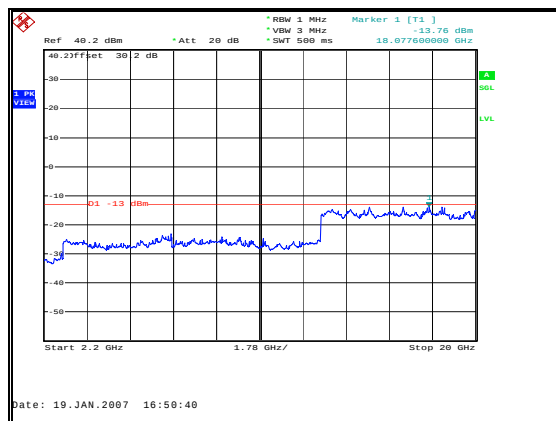


Figure 12: Spurious Emissions - Downlink CDMA Low Channel – Inter-modulation – 2.2 to 20 GHz

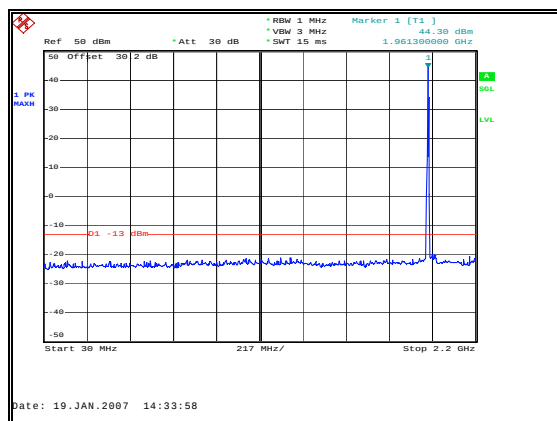


Figure 13: Spurious Emissions - Downlink CDMA Mid Channel – 30 MHz to 2.2 GHz

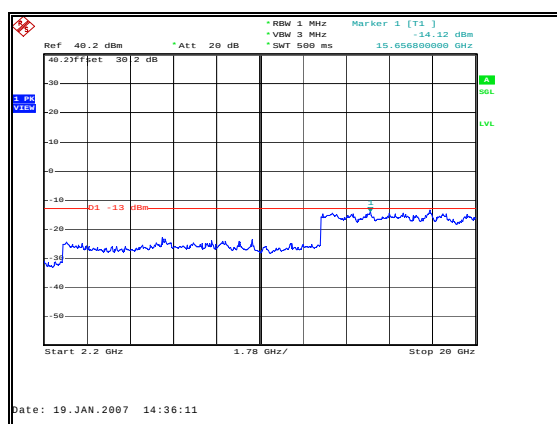


Figure 14: Spurious Emissions - Downlink CDMA Mid Channel – 2.2 to 20 GHz

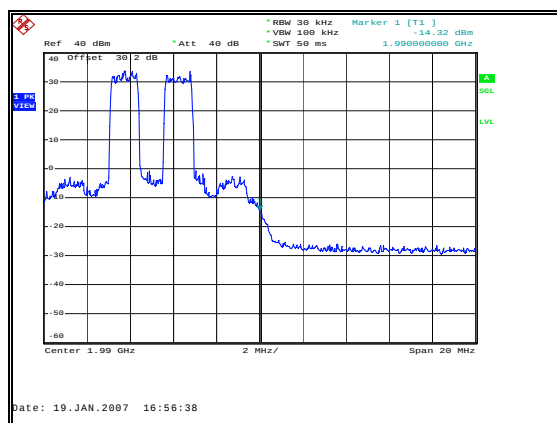


Figure 15: Spurious Emissions - Downlink CDMA High Channel – Inter-modulation In Band

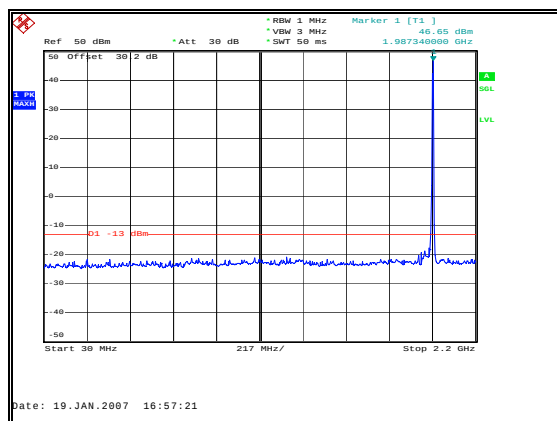


Figure 16: Spurious Emissions - Downlink CDMA High Channel –Inter-modulation-30MHz to 2.2GHz

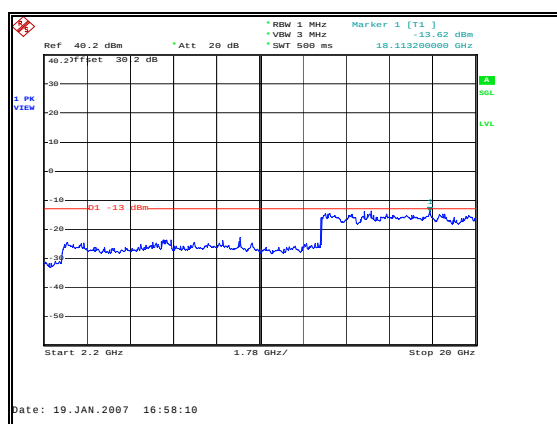


Figure 17: Spurious Emissions - Downlink CDMA High Channel – Inter-modulation – 2.2 to 20 GHz

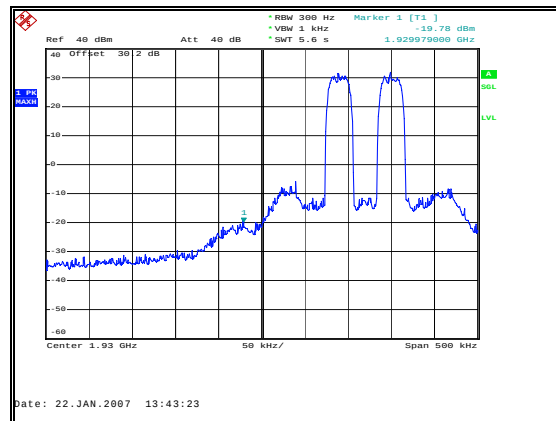


Figure 18: Spurious Emissions - Downlink TDMA Low Channel – Inter-modulation In Band

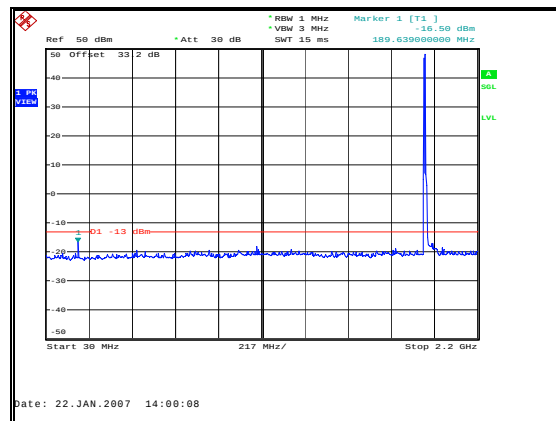


Figure 19: Spurious Emissions - Downlink TDMA Low Channel – Inter-modulation-30MHz to 2.2GHz

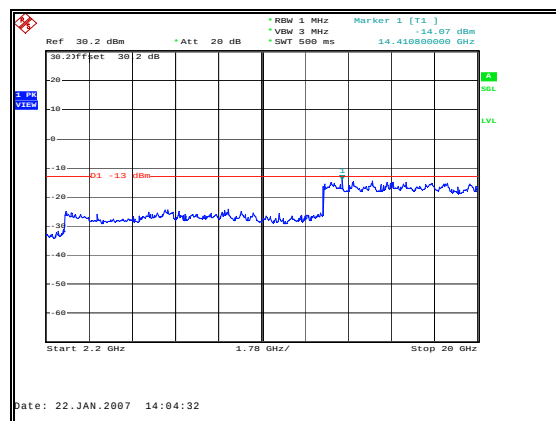


Figure 20: Spurious Emissions - Downlink TDMA Low Channel – Inter-modulation – 2.2 to 20 GHz

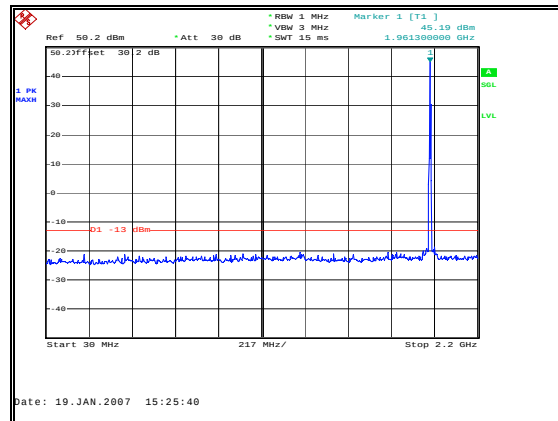


Figure 21: Spurious Emissions - Downlink TDMA Mid Channel – 30 MHz to 2.2 GHz

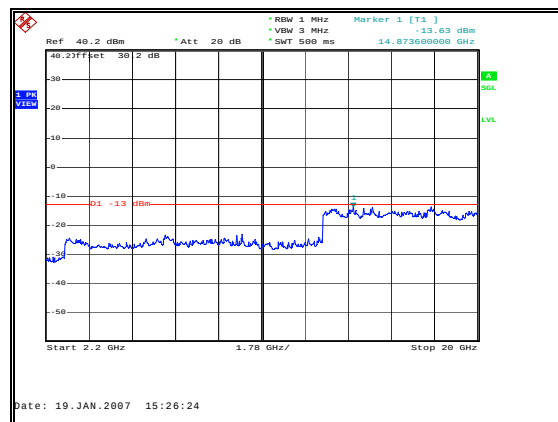


Figure 22: Spurious Emissions - Downlink TDMA Mid Channel – 2.2 to 20 GHz

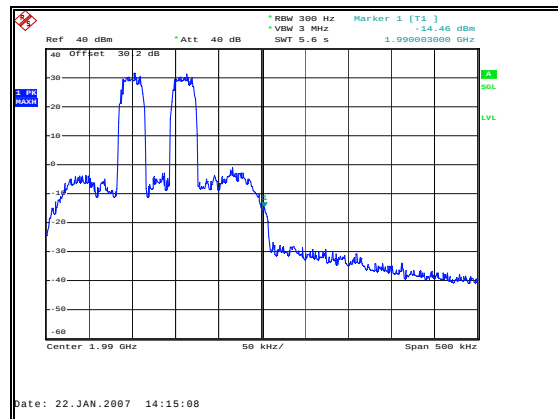


Figure 23: Spurious Emissions - Downlink TDMA High Channel – Inter-modulation In Band

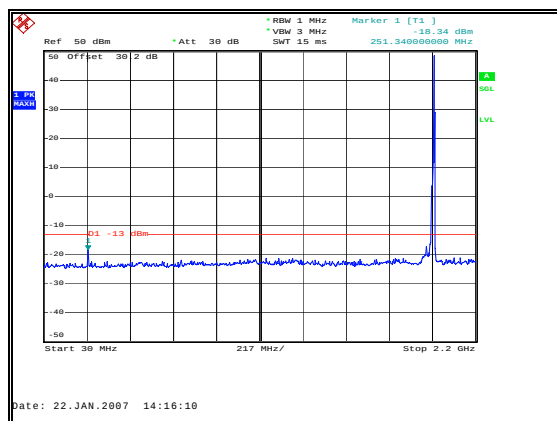


Figure 24: Spurious Emissions - Downlink TDMA High Channel –Inter-modulation-30MHz to 2.2GHz

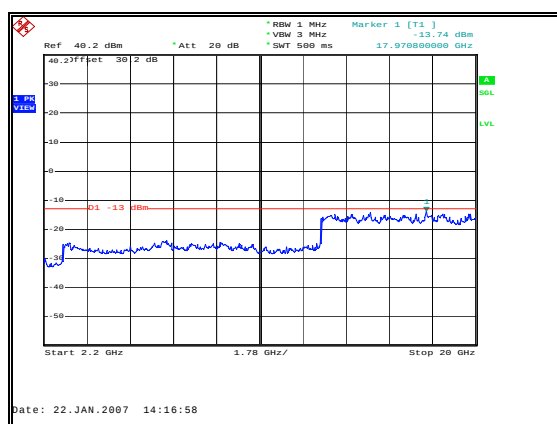


Figure 25: Spurious Emissions - Downlink TDMA High Channel – Inter-modulation – 2.2 to 20 GHz

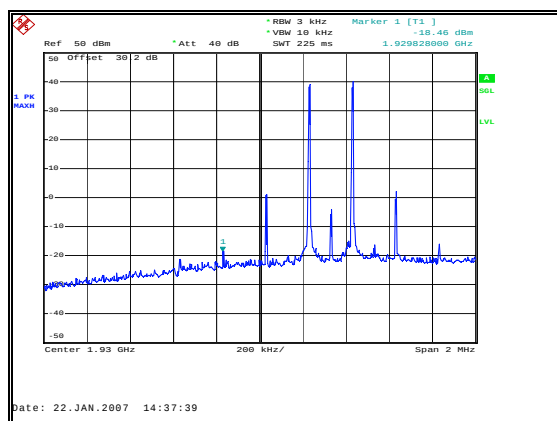


Figure 26: Spurious Emissions - Downlink CW Low Channel – Inter-modulation In Band

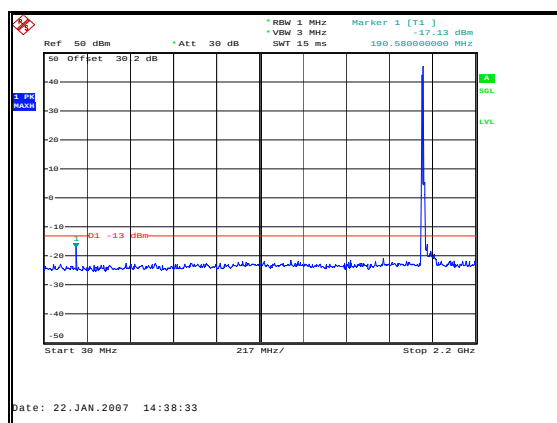


Figure 27: Spurious Emissions - Downlink CW Low Channel – Inter-modulation - 30 MHz to 2.2 GHz

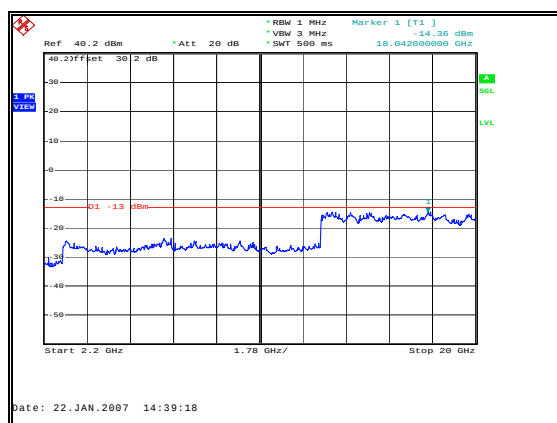


Figure 28: Spurious Emissions - Downlink CW Low Channel – Inter-modulation – 2.2 to 20 GHz

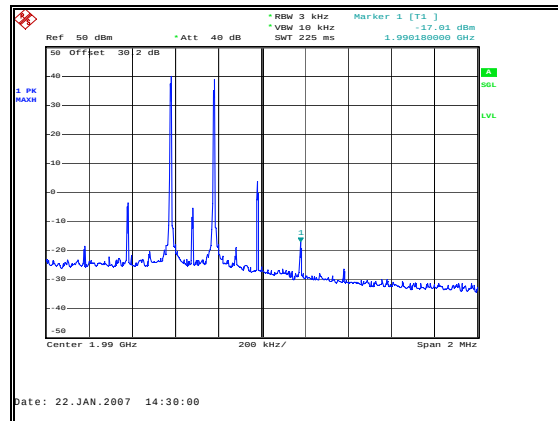


Figure 29: Spurious Emissions - Downlink CW High Channel – Inter-modulation In Band

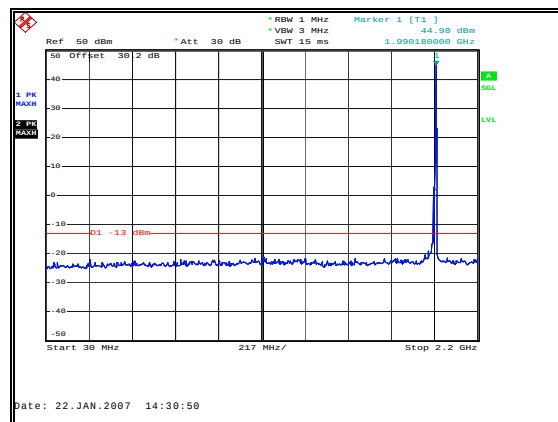


Figure 30: Spurious Emissions - Downlink CW High Channel – Inter-modulation - 30 MHz to 2.2 GHz

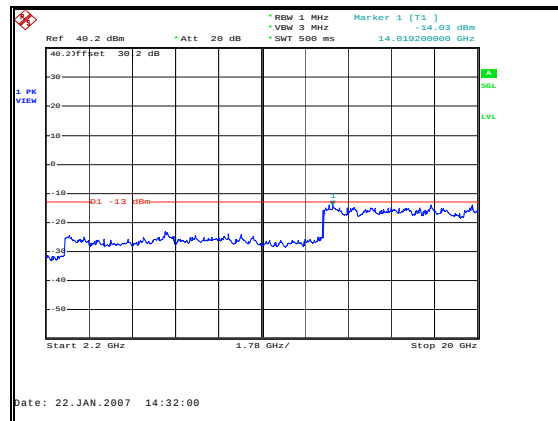


Figure 31: Spurious Emissions - Downlink CW High Channel – Inter-modulation – 2.2 to 20 GHz

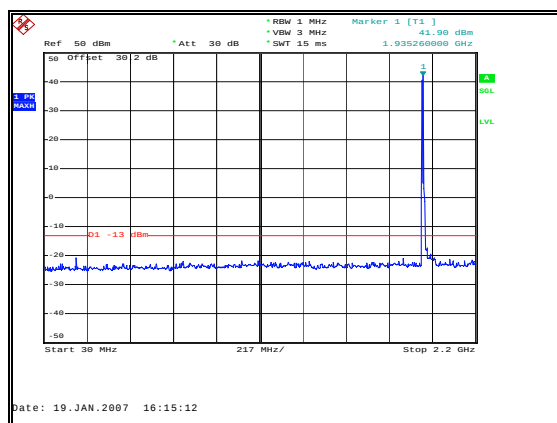


Figure 32: Spurious Emissions - Downlink GSM Low Channel – 30 MHz to 2.2 GHz

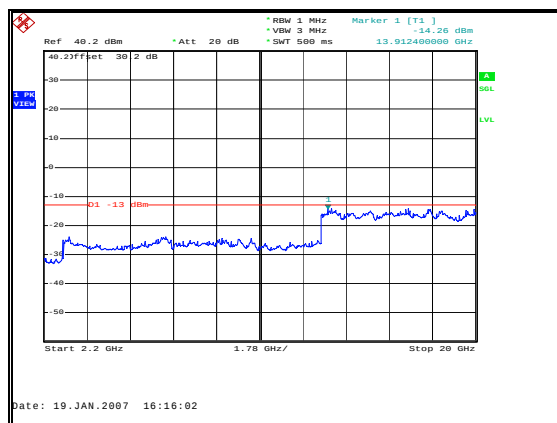


Figure 33: Spurious Emissions - Downlink GSM Low Channel – 2.2 to 20 GHz

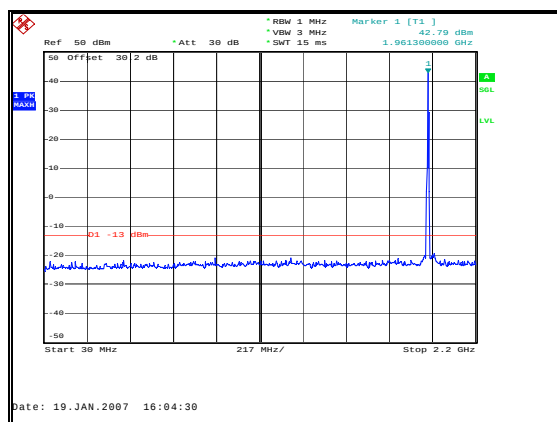


Figure 34: Spurious Emissions - Downlink GSM Mid Channel – 30 MHz to 2.2 GHz

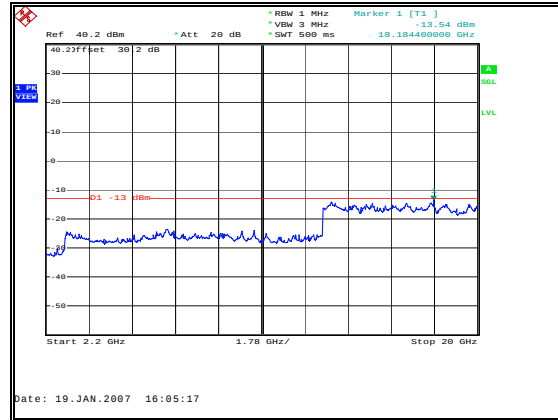


Figure 35: Spurious Emissions - Downlink GSM Mid Channel – 2.2 to 20 GHz

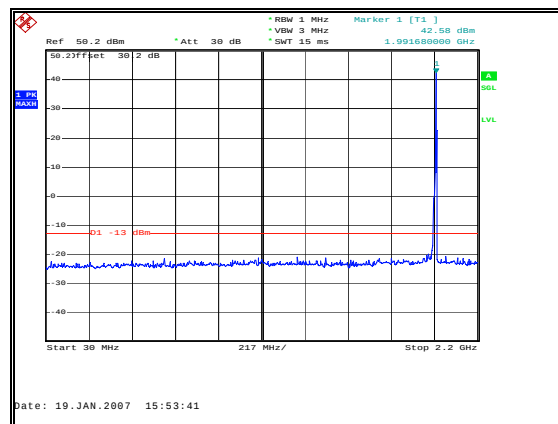


Figure 36: Spurious Emissions - Downlink GSM High Channel – 30 MHz to 2.2 GHz

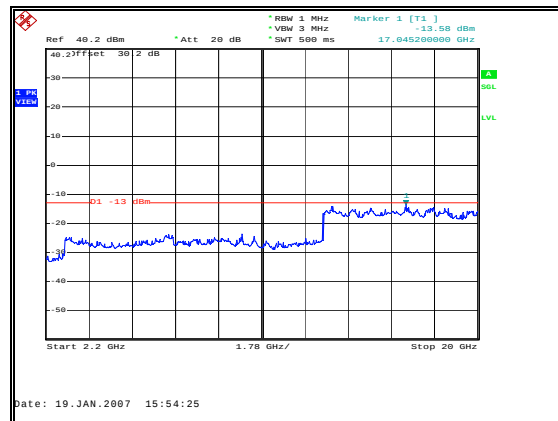


Figure 37: Spurious Emissions - Downlink GSM High Channel – 2.2 to 20 GHz

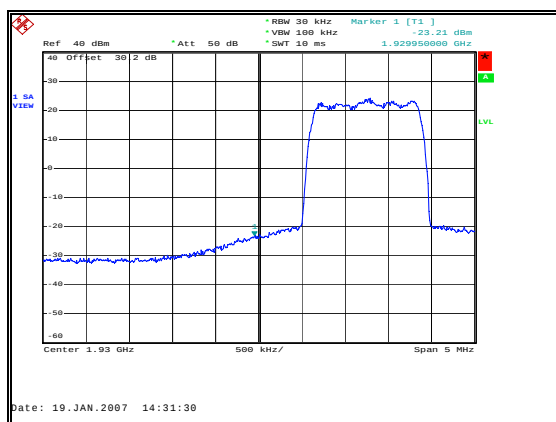


Figure 38: Band-Edge Downlink CDMA Low Channel

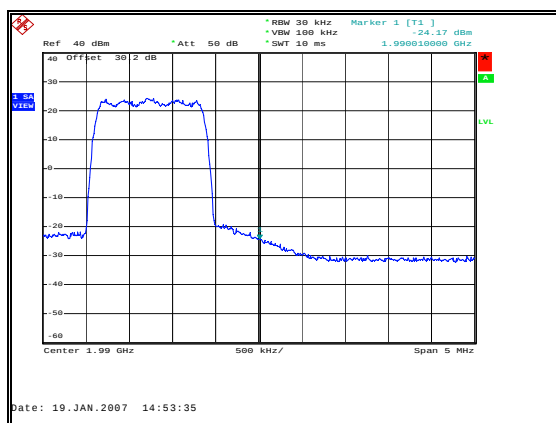


Figure 39: Band-Edge Downlink CDMA High Channel

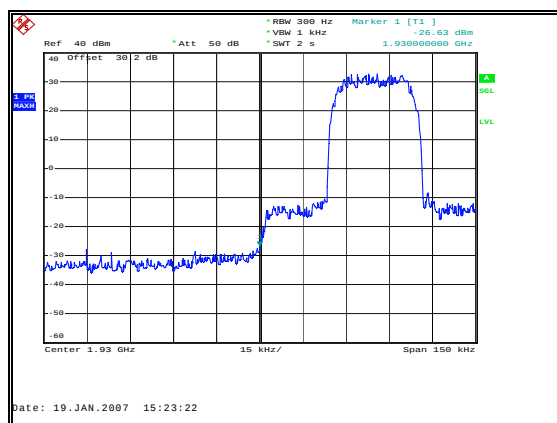


Figure 40: Band-Edge Downlink TDMA Low Channel

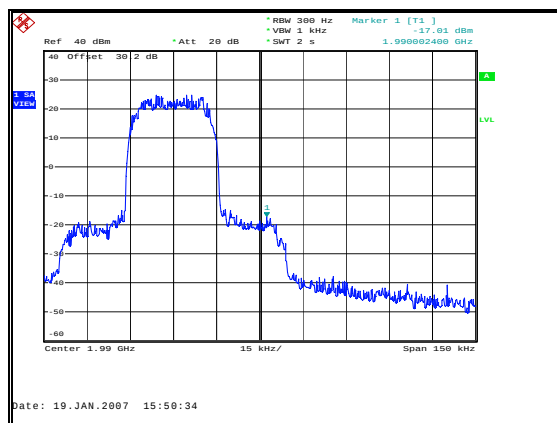


Figure 41: Band-Edge Downlink TDMA High Channel

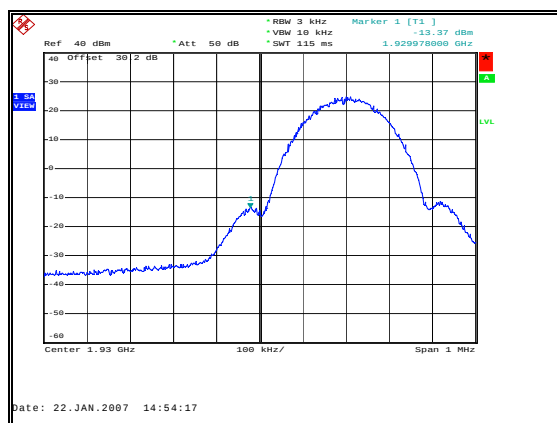


Figure 42: Band-Edge Downlink GSM Low Channel

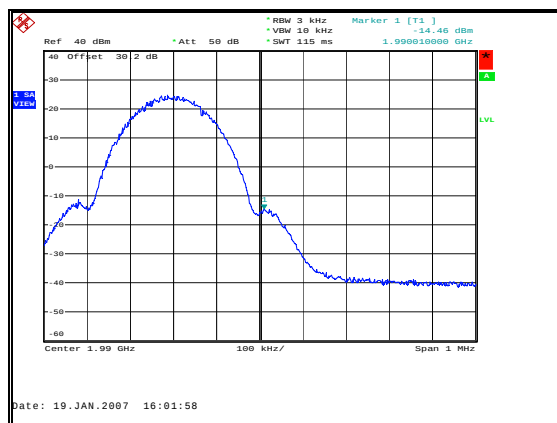


Figure 43: Band-Edge Downlink GSM High Channel
