- h) keep a record of all complaints made known to the us relating to the product's compliance with requirements of the relevant standard and to make these records available to the agent when requested;
- i) take appropriate action with respect to such complaints and any deficiencies found in products or services that affect compliance with the requirements for certification and document the actions taken.
