### 3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10:2013 and FCC CFR 47 Part 15.207, 15.209 and 15.225.

#### 3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

#### 3.3 GENERAL TEST PROCEDURES

#### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in ANSI C63.10:2013. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in ANSI C63.10:2013.

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, ridged waveguide, horn and/or Loop. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."




#### 7.3 FREQUENCY STABILITY

### LIMIT

According to §15.225(e), the frequency tolerance of the carrier signal shall be maintained within +/- 0.01% of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. For battery operated equipment, the equipment tests shall be performed using a new battery.

## **TEST PROCEDURE**

- Turn the EUT off, and place it inside the environmental temperature chamber. 1.
- 2. Set the temperature control on the chamber to the highest specified in the regulatory requirements for the type of device and allow the oscillator heater and the chamber temperature to stabilize.
- Set the spectrum analyzer as RBW=1kHz, VBW = RBW, Span = 200kHz, Sweep = 3. auto.
- Turn the EUT on and record the operating frequency at startup and two, five, and 4. ten minutes after the EUT is energized.
- Switch off the EUT and Lower the chamber temperature by not more than 10 °C and 5. allow the temperature inside the chamber to stabilize.
- 6. Mark the peak frequency and measure the frequency tolerance using frequency counter function.
- Repeat step 4 through step 6 down to the lowest specified temperature. 7.

#### 7.4 POWERLINE CONDUCTED EMISSIONS

### LIMIT

According to §15.207(a), except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 µH/50 ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.


