Fig.1 Photograph of the SAR measurement System




Fig. 2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig. 2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)

Fig.3 Configuration 1




Fig.4 Configuration 1




Fig.6 Configuration 3




Fig.7 Configuration 4

12. Tablet Dimension, Antennas and Sensor location

As seen in Figure 10, the tablet dimension is 199.9 x 119.8 x 12.4 mm3 with diagonal 233 mm. The LCD size is 154 x 93 mm2 with diagonal 179.9 mm.

There is a front camera on top, two speaker meshes at left & right, headset jack at left and SIM&SD slot at right.




Fig.11 Back view

In Figure 11, there are three antennas, one camera, two speakers and data/charger IO from back view. The distance between WWAN and WiFi antenna is 160mm by the minimal physical distance.




Fig.12 Proximity sensor portion in Yellow (from back view)

In Figure 12, the yellow part is the sensor pad. The bigger the sensor pad, the longer the detect distance.
