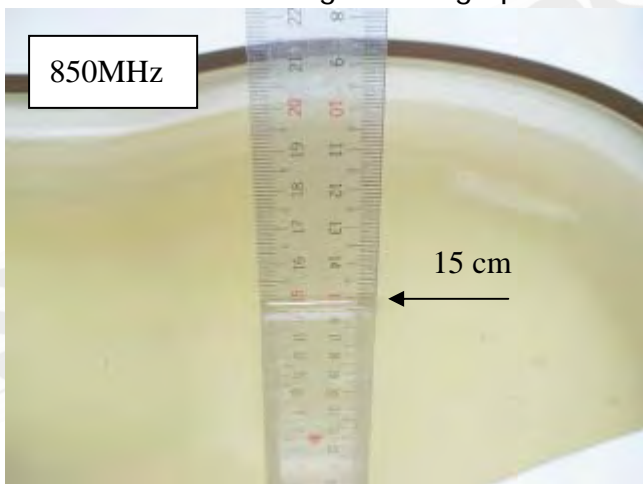

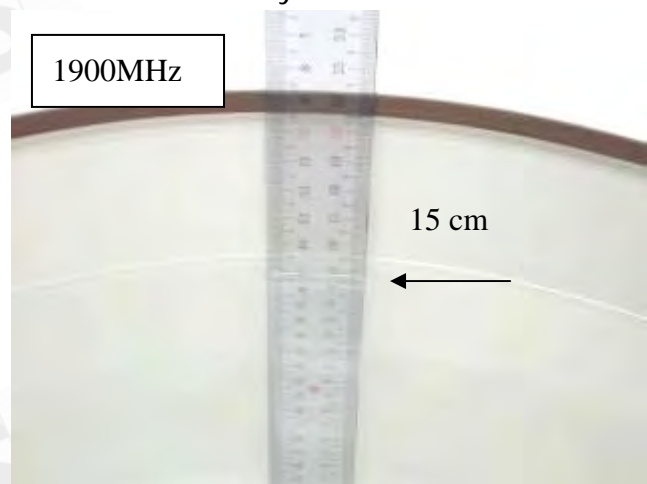


Fig.1 Photograph of the SAR measurement System

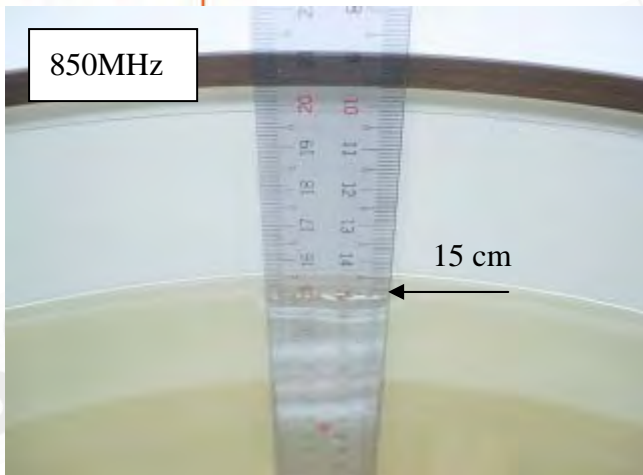

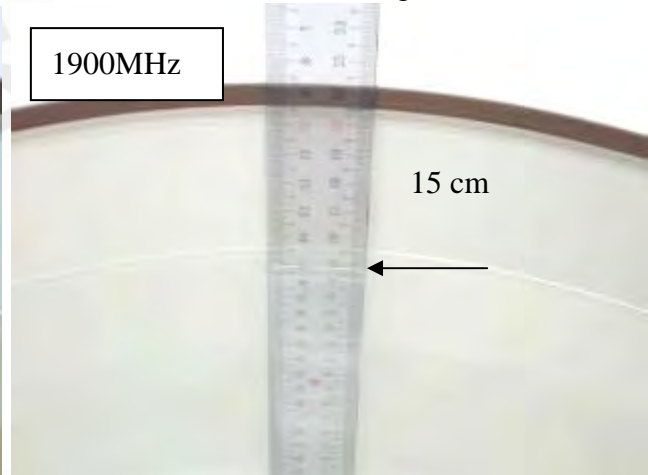

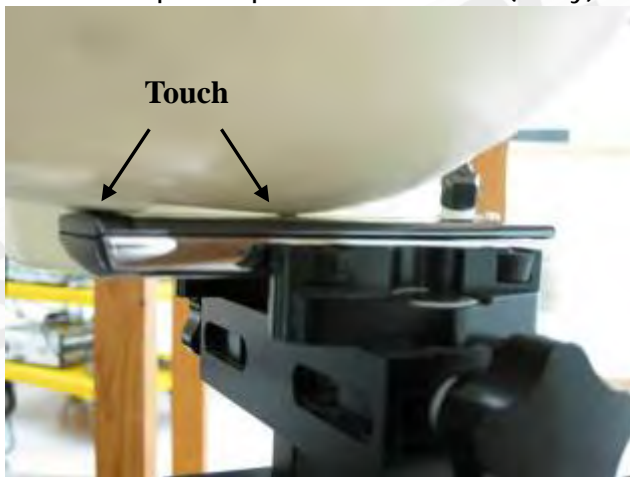
Fig.2.3 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)

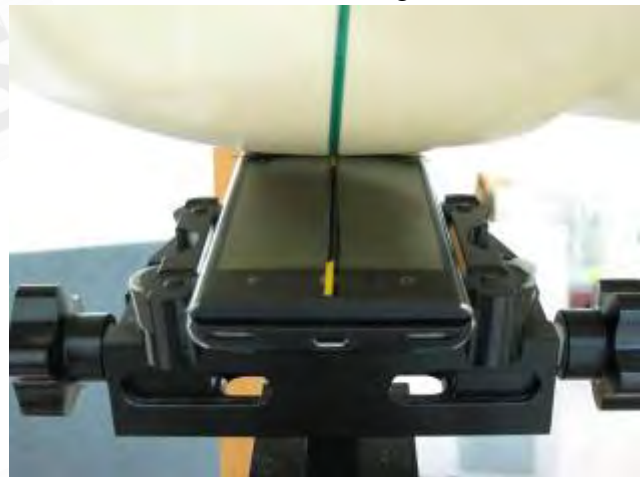


Fig.4 Right Head Section / Ear-Tilt Position(15°)_ Slider off

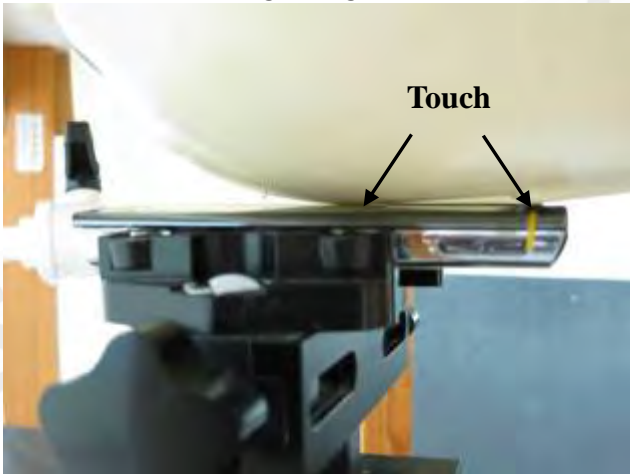


Fig.5 Left Head Section / Cheek-Touch Position_ Slider off

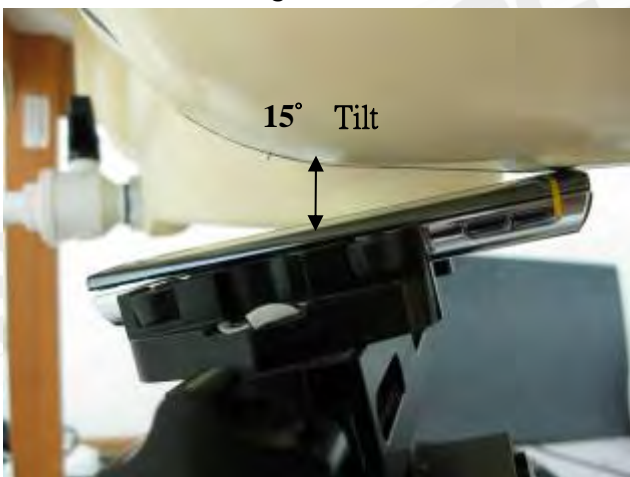


Fig.6 Left Head Section / Ear-Tilt Position(15°)_ Slider off

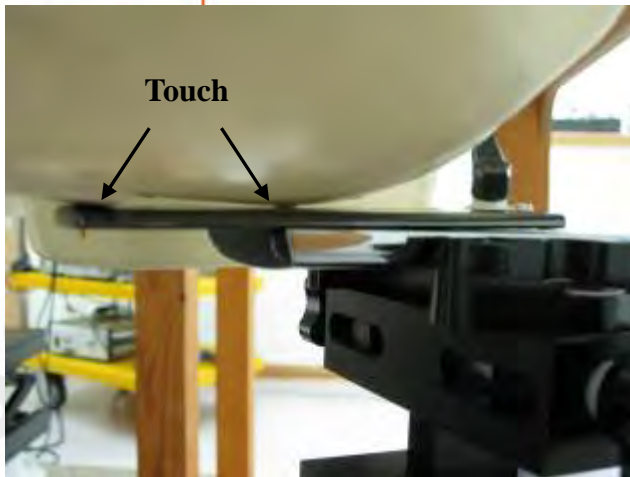


Fig.7 Right Head Section / Cheek-Touch Position_ Slider on

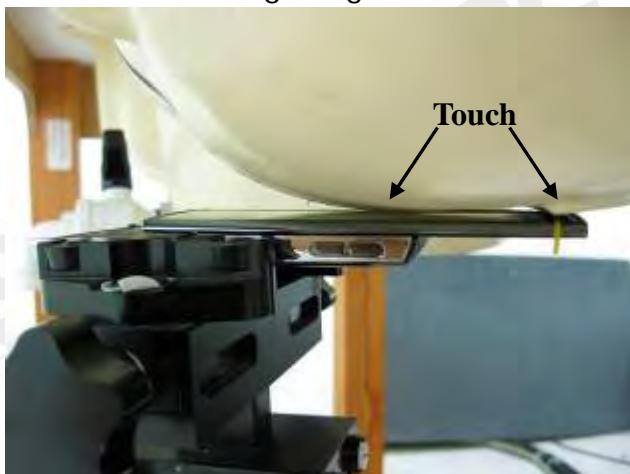


Fig.9 Left Head Section / Cheek-Touch Position_ Slider on

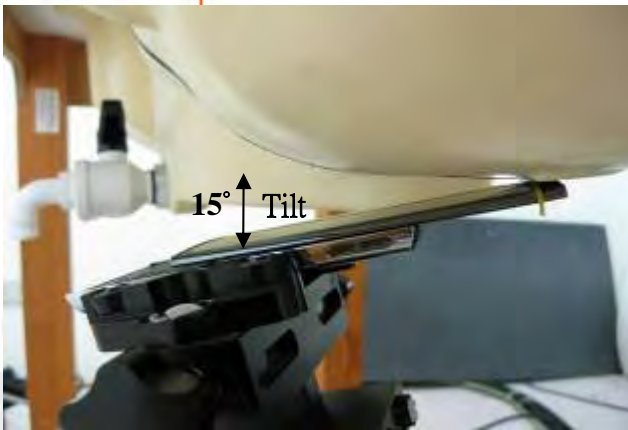


Fig.10 Left Head Section / Ear-Tilt Position(15°)_ Slider on

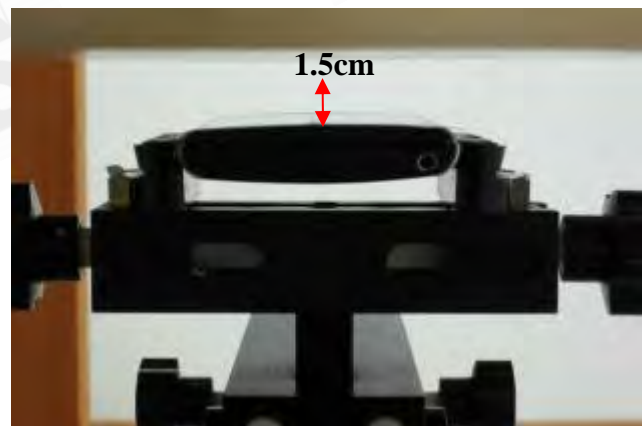


Fig.11 Body worn- EUT front to flat phantom and distance between flat phantom and mobile phone is 1.5 cm

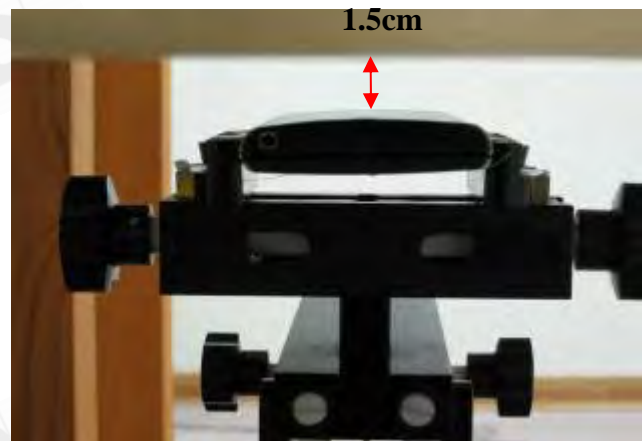


Fig.12 Body worn- EUT back to flat phantom and distance between flat phantom and mobile phone is 1.5 cm
