






Fig.2.3 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.2.5 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body) Fig.2.4 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.4 Right Head Section / Ear-Tilt Position(15°)




Fig.5 Left Head Section / Cheek-Touch Position




Fig.8 Body worn- EUT back to flat phantom and distance between flat phantom and mobile phone is 1.5 cm




Fig.9 Body worn- EUT back to flat phantom and distance between flat phantom and mobile phone is 1.5 cm (repeated with headset)

#### Fig.11 Back view of device


