1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 PCTEST Test Location

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014.

1.3 Test Facility / Accreditations

Measurements were performed at PCTEST Engineering Lab located in Columbia, MD 21046, U.S.A.


3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the document titled "Land Mobile FM or PM – Communications Equipment – Measurements and Performance Standards" (ANSI/TIA-603-E-2016) and "Procedures for Compliance Measurement of the Fundamental Emission Power of Licensed Wideband (> 1 MHz) Digital Transmission Systems" (KDB 971168 D01 v03r01) were used in the measurement of the EUT.

3.2 Broadband Frequency Assignment

The spectrum for this band is allocated as shown below.



3.3 Radiated Power and Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to its integral antenna and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer.

For radiated power measurements, substitution method is used per the guidance of ANSI/TIA-603-E-2016. A halfwave dipole is substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator with the level of the signal generator being adjusted to obtain the same receive spectrum analyzer level previously recorded from the spurious emission from the EUT. The power of the emission is calculated using the following formula:

where Pd is the dipole equivalent power, Pg is the generator output into the substitution antenna, and the antenna gain is the gain of the substitute antenna used relative to either a half-wave dipole (dBd) or an isotropic source (dBi). The substitute level is equal to $P_{g [dBm]}$ – cable loss [dB].

For radiated spurious emissions measurements and calculations, conversion method is used per the formulas in KDB 971168 Section 5.8.4. Field Strength (EIRP) is calculated using the following formulas:

 $E_{[dB\mu V/m]}$ = Measured amplitude level $_{[dBm]}$ + 107 + Cable Loss $_{[dB]}$ + Antenna Factor $_{[dB/m]}$ And $EIRP_{[dBm]}$ = $E_{[dB\mu V/m]}$ + 20logD - 104.8; where D is the measurement distance in meters.

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4-2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 474788 D01.

Radiated power and radiated spurious emission levels are investigated with the receive antenna horizontally and vertically polarized per ANSI/TIA-603-E-2016.

4.0 MEASUREMENT UNCERTAINTY

Spurious Radiated Emission – LTE Band

Example: Middle Channel LTE Mode 2nd Harmonic (1564 MHz)

The average spectrum analyzer reading at 3 meters with the EUT on the turntable was -81.0 dBm. The gain of the substituted antenna is 8.1 dBi. The signal generator connected to the substituted antenna terminals is adjusted to produce a reading of -81.0 dBm on the spectrum analyzer. The loss of the cable between the signal generator and the terminals of the substituted antenna is 2.0 dB at 1564 MHz. So 6.1 dB is added to the signal generator reading of -30.9 dBm yielding -24.80 dBm. The fundamental EIRP was 25.501 dBm so this harmonic was 25.501 dBm - (-24.80).

- 1) All modes of operation and data rates were investigated. The test results shown in the following sections represent the worst case emissions.
- 2) The analyzer plots shown in Section 7.0 were taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables, directional couplers, and attenuators used as part of the system to maintain a link between the call box and the EUT at all frequencies of interest.
- 3) All antenna port conducted emissions testing was performed on a test bench with the antenna port of the EUT connected to the spectrum analyzer through calibrated cables, attenuators, and couplers.
- 4) For conducted spurious emissions, automated test software was used to measure emissions and capture the corresponding plots necessary to show compliance.

7.2 **Transmitter Conducted Output Power**

Test Overview

The transmitter conducted outure power is a measure of the total average power contained within a 3MHz channel as defined in §27.1506. All modes of operation were investigated and the worst case configuration results are reported in this section.

Test Procedure Used

ANSI C63.26-2015 - Section 5.2.4.4.1

Test Settings

- 1. The signal analyzer's Channel Power measurement capability was used to perform the channel power.
- 2. Span = 2x to 3x times the Occupied Bandwidth
- 3. RBW = 1 5% of the expected OBW
- 4. $VBW \ge 3 \times RBW$
- 5. Number of measurements points ≥ 2 x span / RBW
- 6. Sweep = auto couple
- 7. Detector = power averaging (RMS)
- 8. Trace mode = trace averaging with no trigger (free run) over 100 sweeps
- 9. The trace was allowed to stabilize






Plot 7-1. Conducted Output Power (QPSK, 1RB, RB Offset 0)


Plot 7-2. Conducted Output Power (QPSK, 1RB, RB Offset 7)




Plot 7-3. Conducted Output Power (QPSK, 1RB, RB Offset 14)

Plot 7-4. Conducted Output Power (QPSK, 15RB (Full), RB Offset 0)




Plot 7-5. Conducted Output Power (16-QAM, 1RB, RB Offset 0)



Plot 7-6. Conducted Output Power (16-QAM, 1RB, RB Offset 7)




Plot 7-7. Conducted Output Power (16-QAM, 1RB, RB Offset 14)

Occupied Bandwidth 7.3

Test Overview

The occupied bandwidth, that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured. All modes of operation were investigated and the worst case configuration results are reported in this section.

Test Procedure Used

ANSI C63.26-2015 - Section 5.4.4

Test Settings

- 1. The signal analyzer's automatic bandwidth measurement capability was used to perform the 99% occupied bandwidth and the 26dB bandwidth. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
- 2. RBW = 1 5% of the expected OBW
- 3. VBW \geq 3 x RBW
- 4. Detector = Peak
- 5. Trace mode = max hold
- 6. Sweep = auto couple
- 7. The trace was allowed to stabilize
- 8. If necessary, steps 2 7 were repeated after changing the RBW such that it would be within
 - 1-5% of the 99% occupied bandwidth observed in Step 7






Plot 7-10. Occupied Bandwidth Plot (QPSK, 1RB, RB Offset 7)

7.4 Spurious and Harmonic Emissions at Antenna Terminal

Test Overview

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. The spectrum is scanned from the lowest frequency generated in the equipment up to a frequency including its 10th harmonic. All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at maximum power, and at the appropriate frequencies. All modes of operation were investigated and the worst case configuration results are reported in this section.

The minimum permissible attenuation level of any spurious emission is 43 + 10log₁₀(P_[Watts]), where P is the transmitter power in Watts.




Plot 7-13. Conducted Spurious Plot (QPSK, 1RB, RB Offset 0)


Plot 7-14. Conducted Spurious Plot (QPSK, 1RB, RB Offset 0)




Plot 7-15. Conducted Spurious Plot (QPSK, 1RB, RB Offset 0)


Plot 7-16. Conducted Spurious Plot (QPSK, 1RB, RB Offset 14)




Plot 7-17. Conducted Spurious Plot (QPSK, 1RB, RB Offset 14)


Plot 7-18. Conducted Spurious Plot (QPSK, 1RB, RB Offset 14)


Plot 7-20. Conducted Spurious Plot (QPSK, 6RB, RB Offset 5)

Plot 7-22. Conducted Spurious Plot (QPSK, 15RB (Full), RB Offset 0)




Plot 7-23. Conducted Spurious Plot (QPSK, 15RB (Full), RB Offset 0)

7.5 Band Edge Emissions at Antenna Terminal



Plot 7-26. Band Edge Plot (QPSK, 1RB, RB Offset 14)




Plot 7-27. Band Edge Plot (QPSK, 6RB, RB Offset 5)



7.6 Peak-Average Ratio

Test Overview

A peak to average ratio measurement is performed at the conducted port of the EUT. The spectrum analyzers Complementary Cumulative Distribution Function (CCDF) measurement profile is used to determine the largest deviation between the average and the peak power of the EUT in a given bandwidth. The CCDF curve shows how much time the peak waveform spends at or above a given average power level. The percent of time the signal spends at or above the level defines the probability for that particular power level.





Plot 7-31. Peak to Average Ratio (QPSK, Full RB)




Plot 7-32. Peak to Average Ratio (QPSK, 1RB Offset 7)







Figure 7-6. Test Instrument & Measurement Setup

7.8 Frequency Stability / Temperature Variation

Test Overview and Limit

Frequency stability testing is performed in accordance with the guidelines of ANSI/TIA-603-E-2016. The frequency stability of the transmitter is measured by:

- Temperature: The temperature is varied from -30°C to +50°C in 10°C increments using an environmental a.) chamber.
- **Primary Supply Voltage:** The primary supply voltage is varied from 85% to 115% of the nominal value for b.) non hand-carried battery and AC powered equipment. For hand-carried, battery-powered equipment, primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacturer.

Test Settings

- 1. The carrier frequency of the transmitter is measured at room temperature (20°C to provide a reference).
- 2. The equipment is turned on in a "standby" condition for fifteen minutes before applying power to the transmitter. Measurement of the carrier frequency of the transmitter is made within one minute after applying power to the transmitter.
- 3. Frequency measurements are made at 10°C intervals ranging from -30°C to +50°C. A period of at least one half-hour is provided to allow stabilization of the equipment at each temperature level.

Based on the results of the frequency stability test at the center channel the frequency deviation results measured are very small. As such it is determined that the channels at the band edge would remain in-band when the maximum measured frequency deviation noted during the frequency stability tests is applied. Therefore the device is determined to remain operating in band over the temperature and voltage range as tested.


