4.2 EUT OPERATION CONDITION

1. Turn on the power of all equipment.
2. PC reads a test program to enable all functions.
3. PC reads and writes messages from FDD and HDD.
4. EUT sends "H" character to PC.
5. PC sends "H" messages to monitor and monitor displays "H" patterns on screen.
6. PC sends "H" messages to modem.
7. PC sends "H" messages to printer, and the printer prints them on paper.
8. PC sends audio messages to speaker.
9. Repeat steps 3-9.

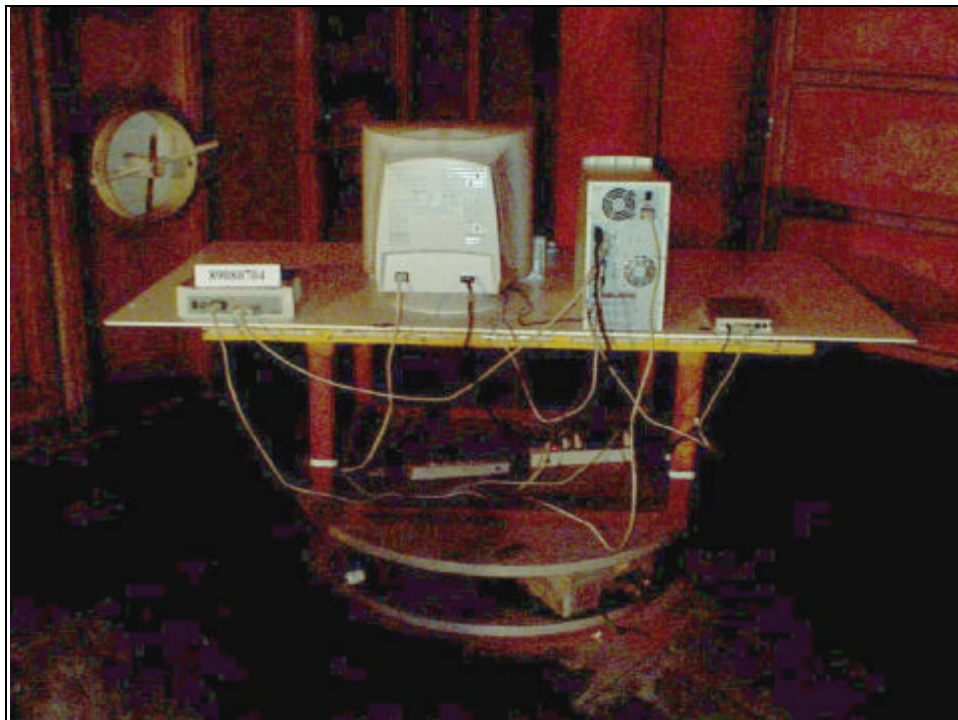


5. PHOTOGRAPHS OF THE TEST CONFIGURATION WITH MINIMUM MARGIN
