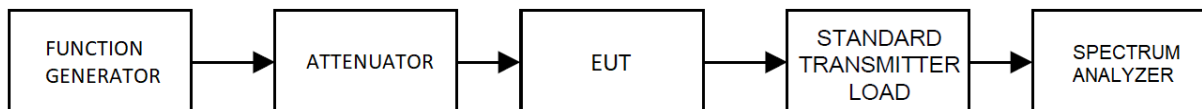

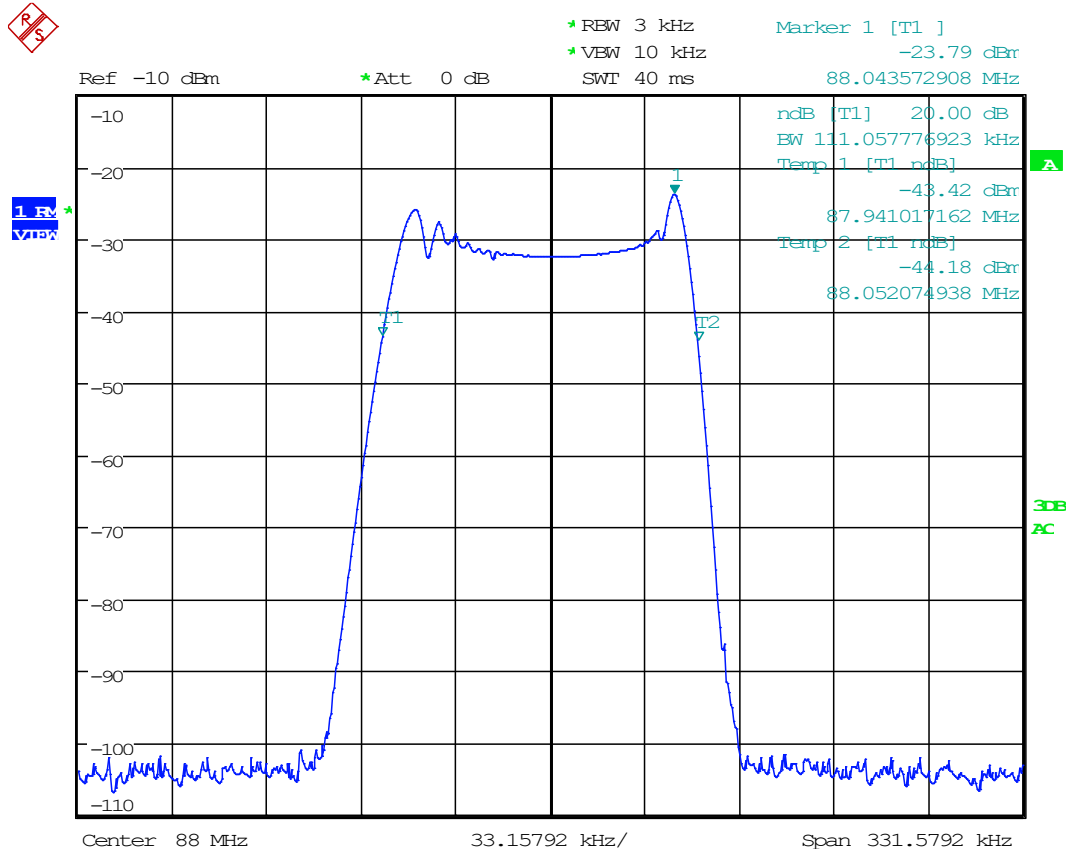

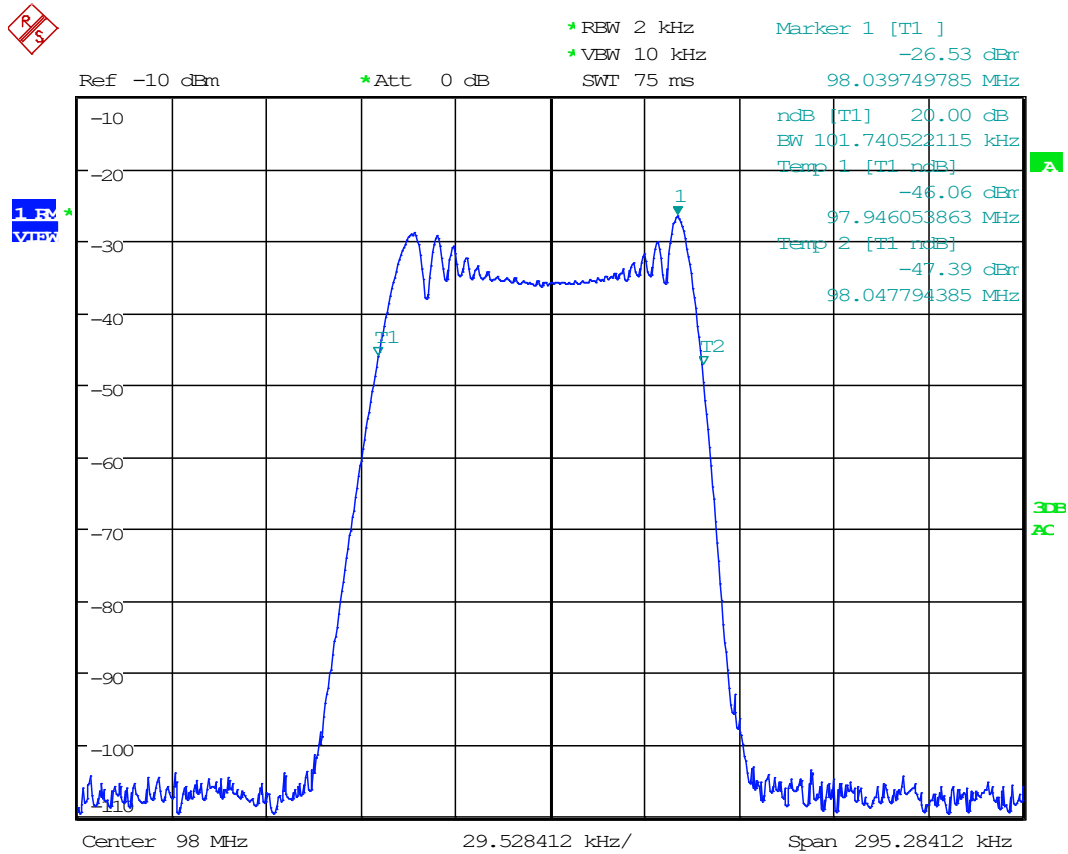

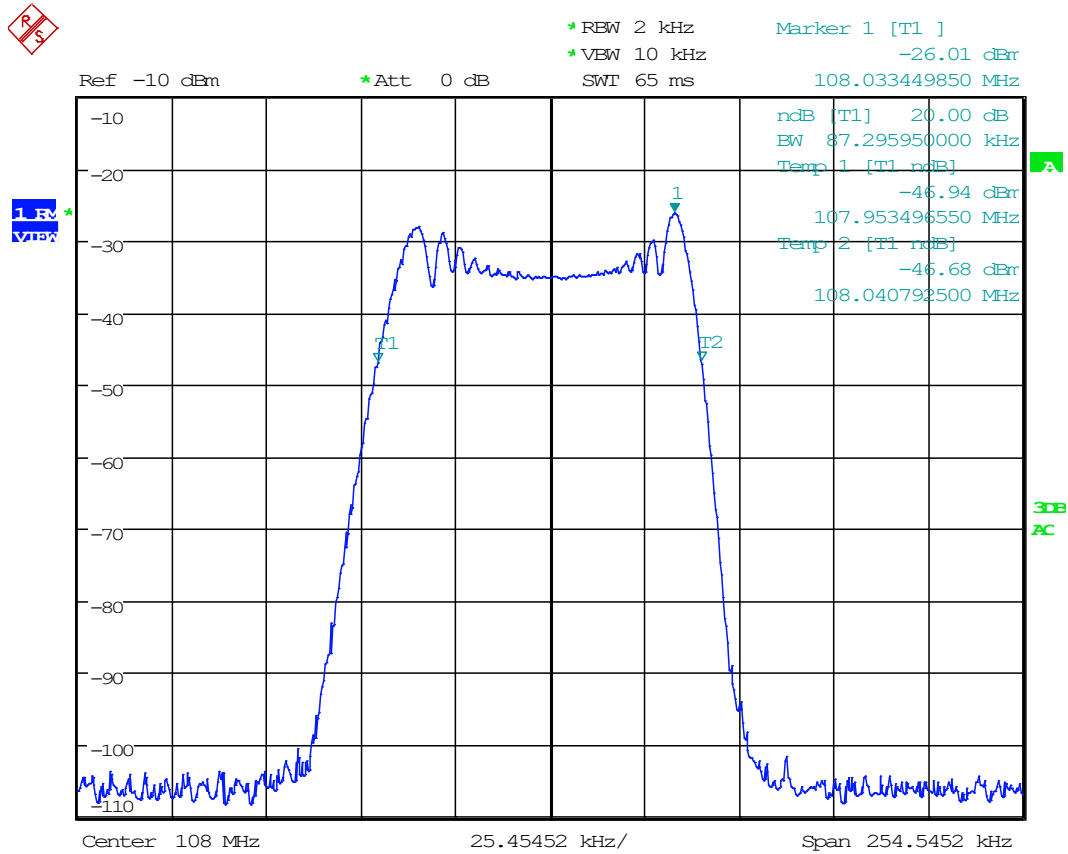

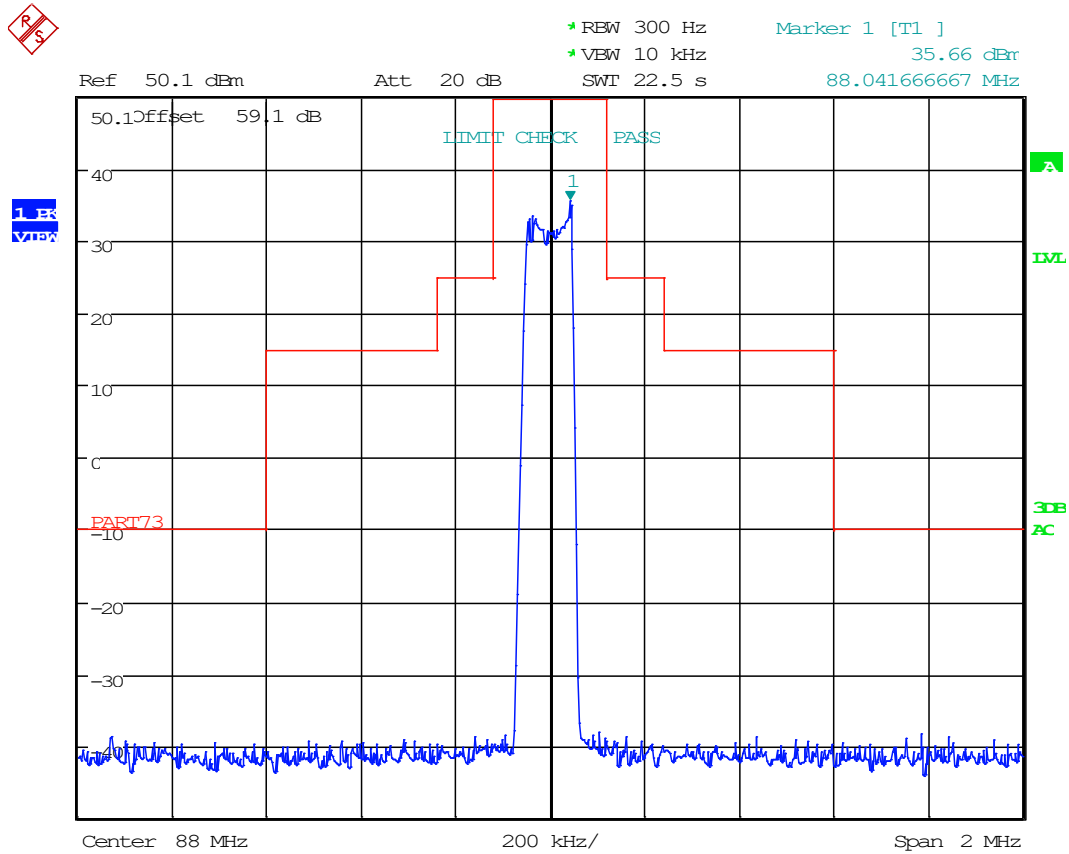

8.5.3 20dB Bandwidth Plot, 108 MHz



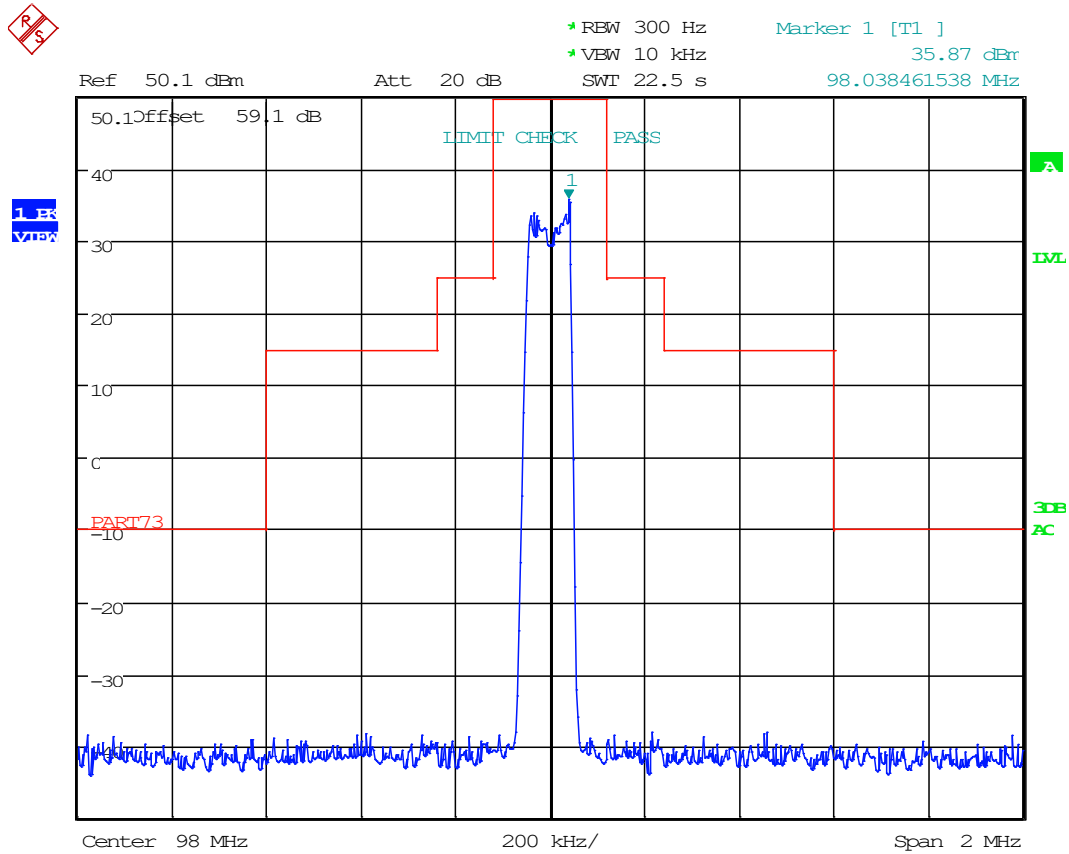

8.5.4 Emission Mask Plot, 88 MHz



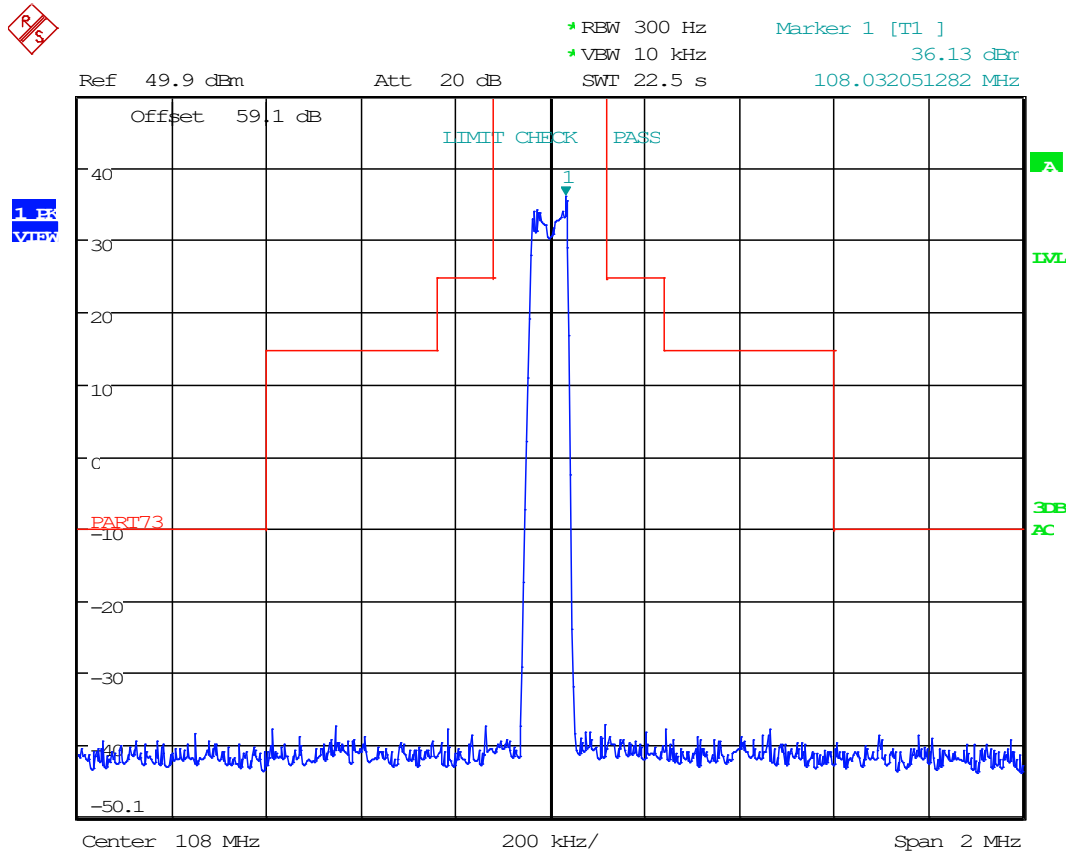

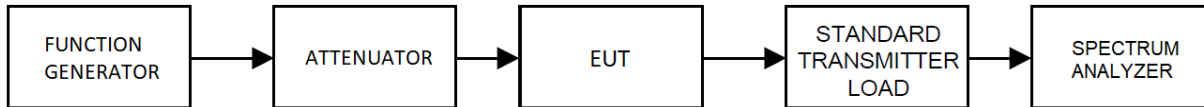

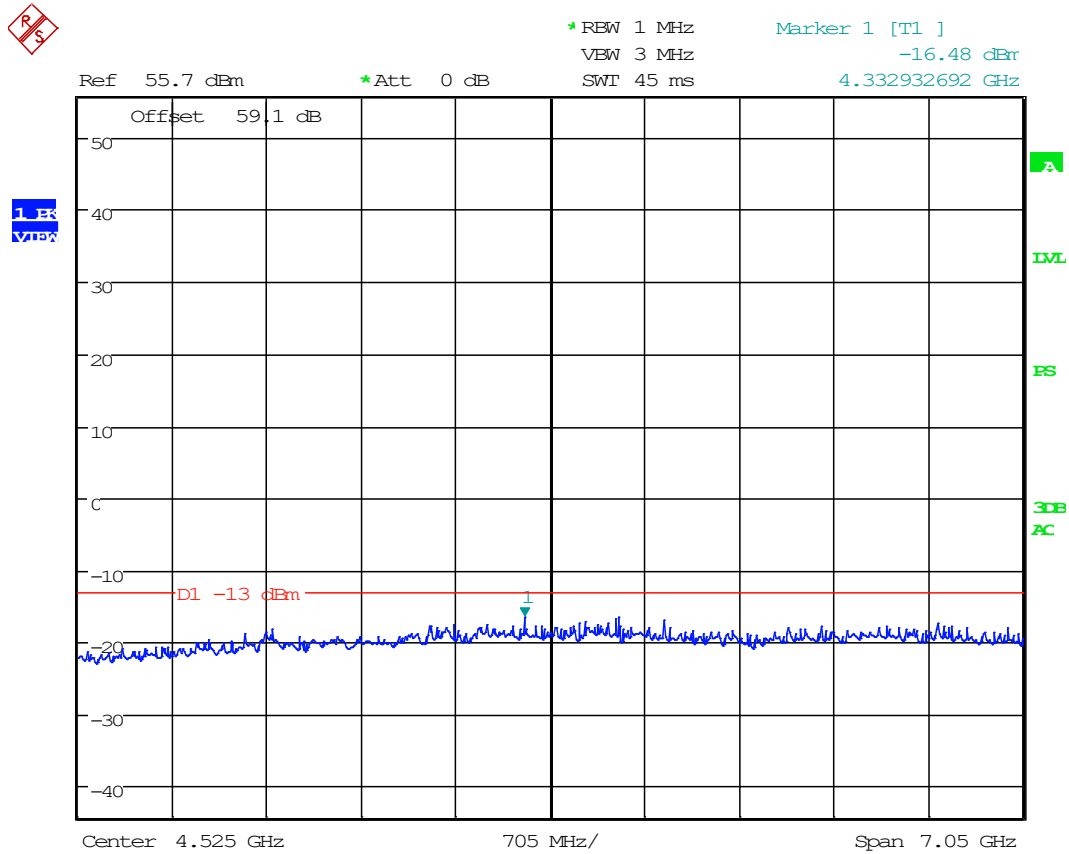


8.6.1 Spurious Emissions Below 1GHz, 88 MHz



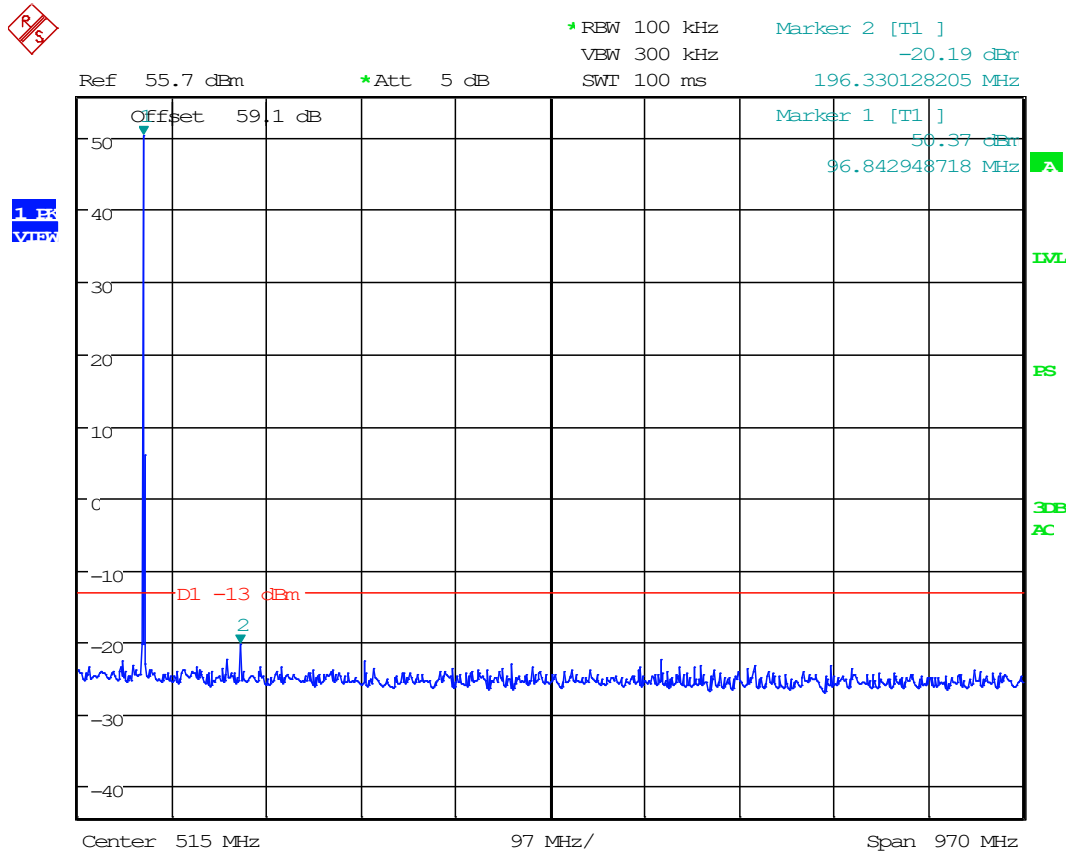

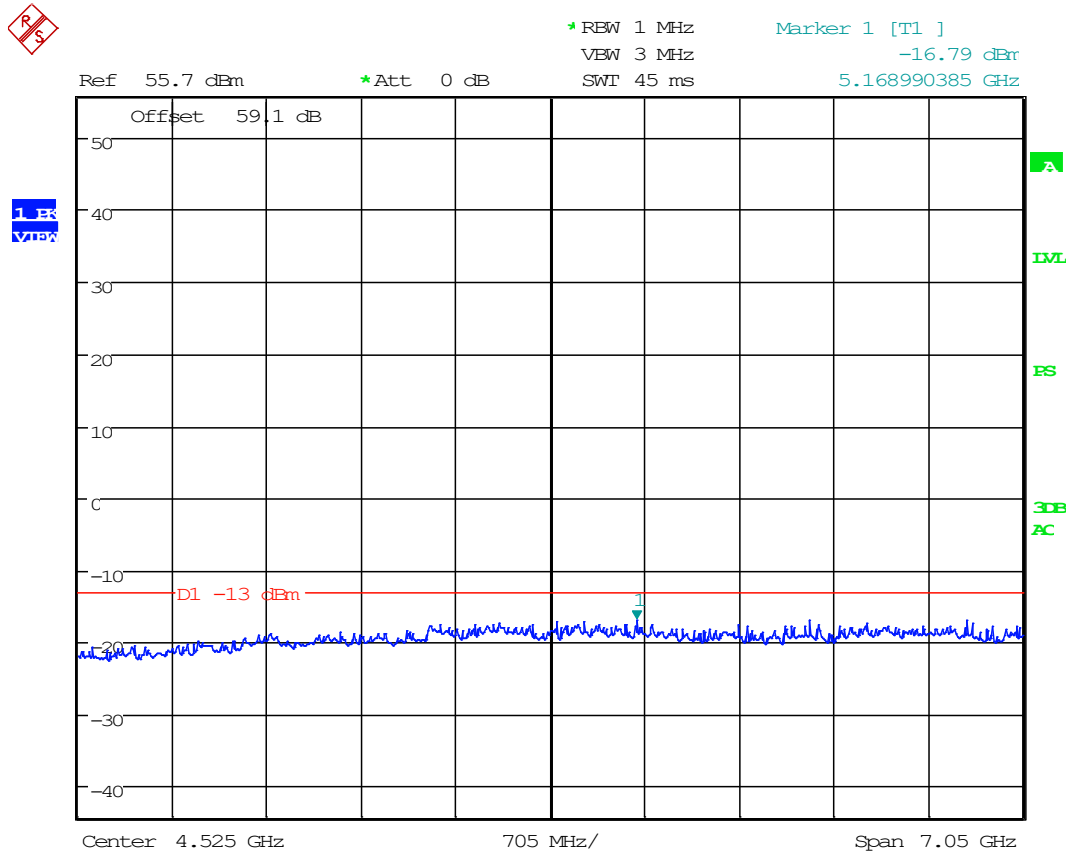

8.6.2 Spurious Emissions Below 1GHz, 98 MHz



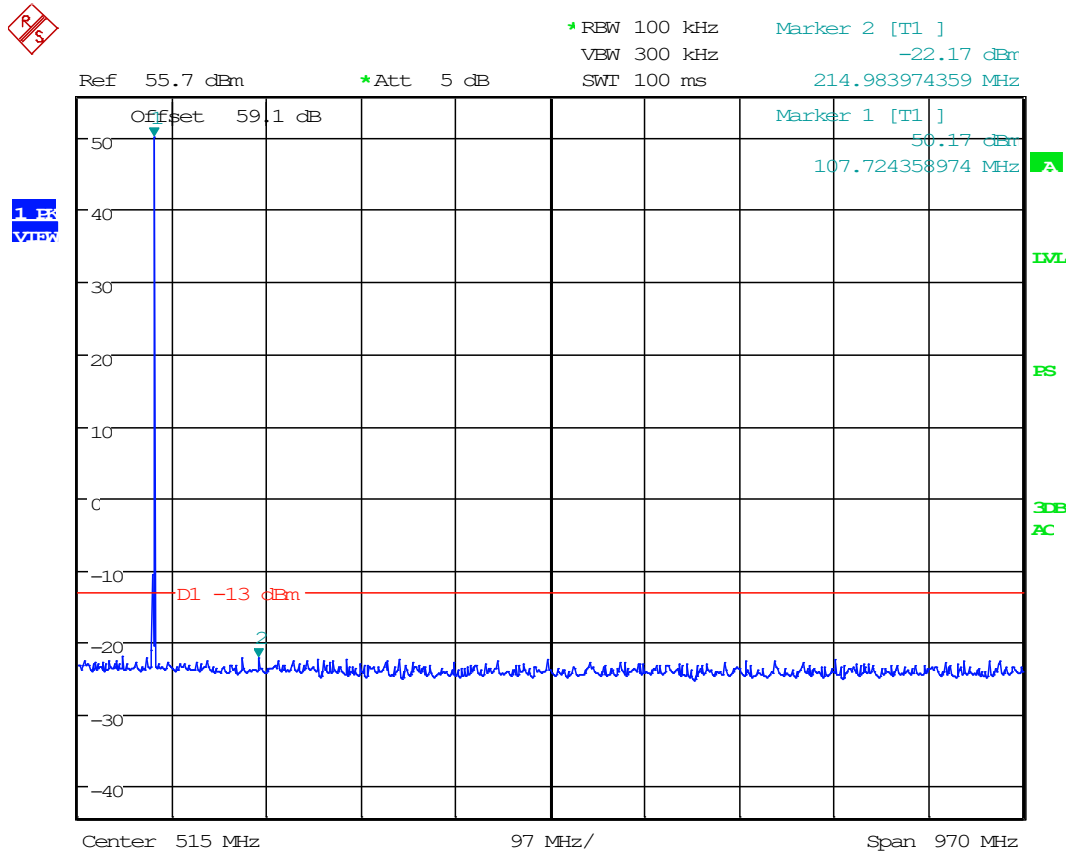

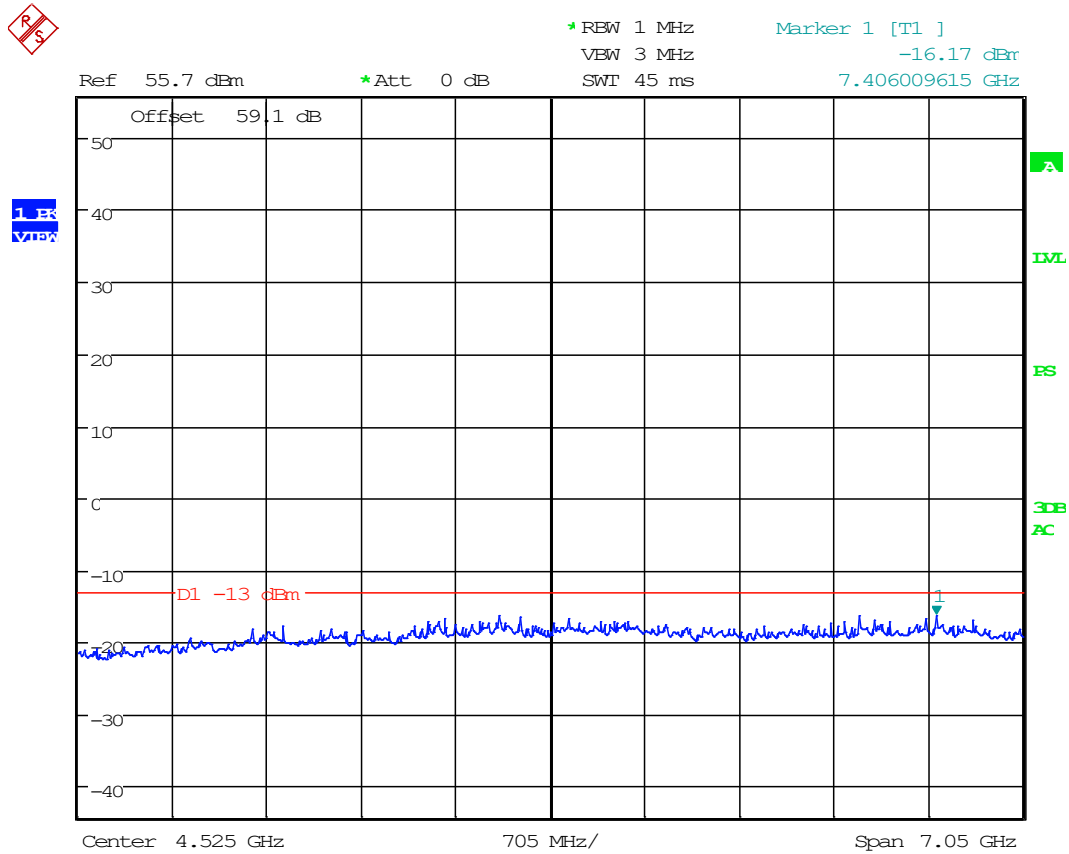

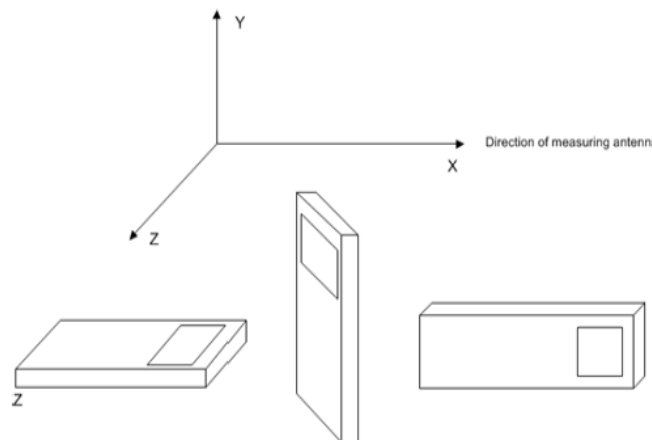

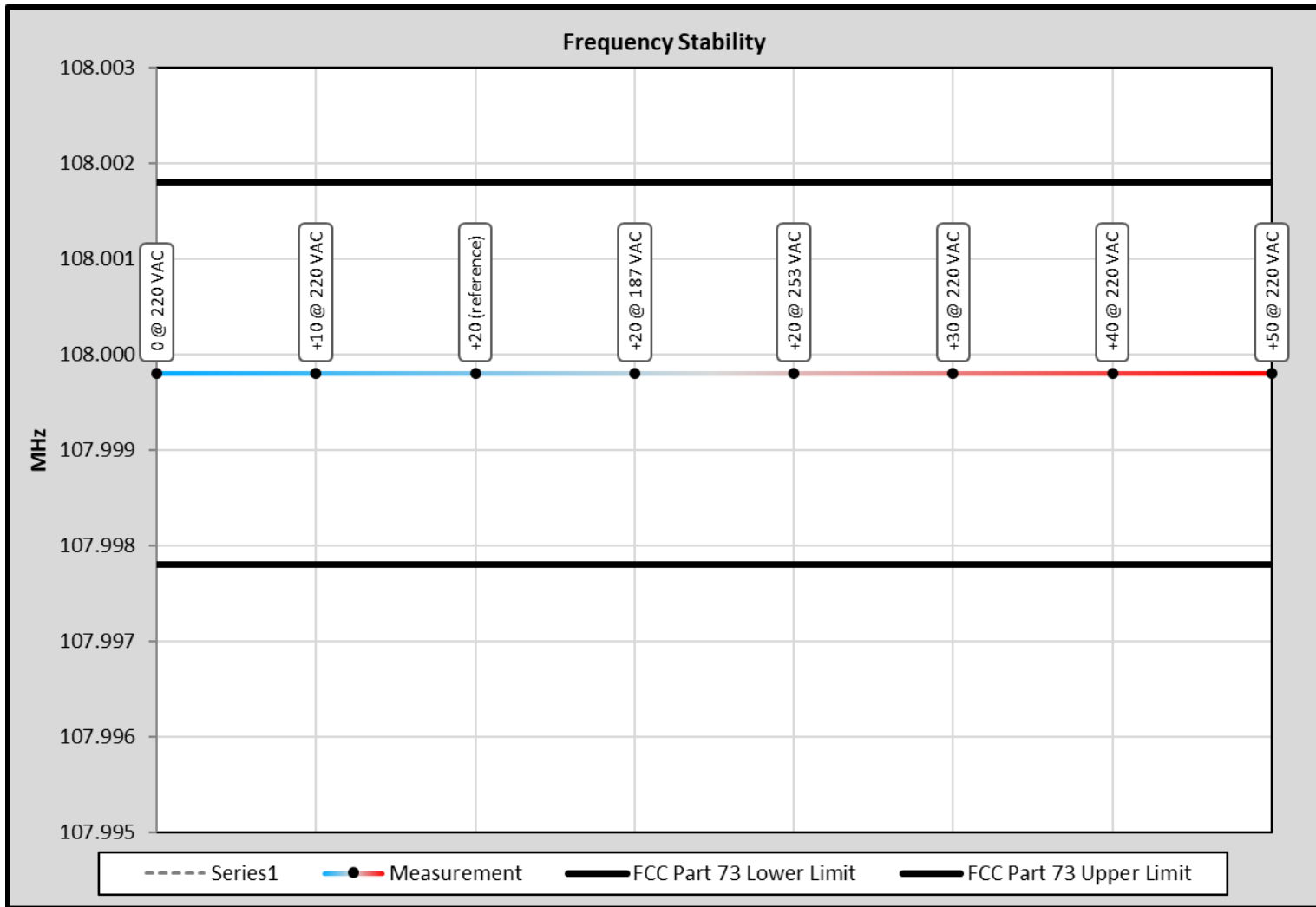
