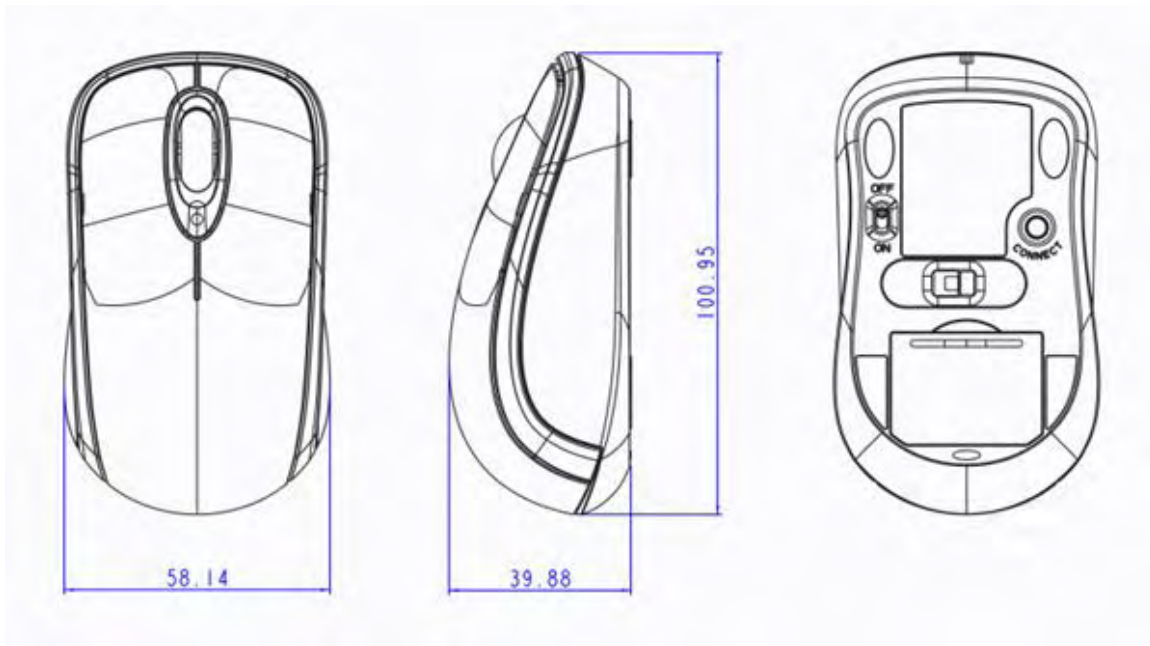

1. BT Connection distance: 10M

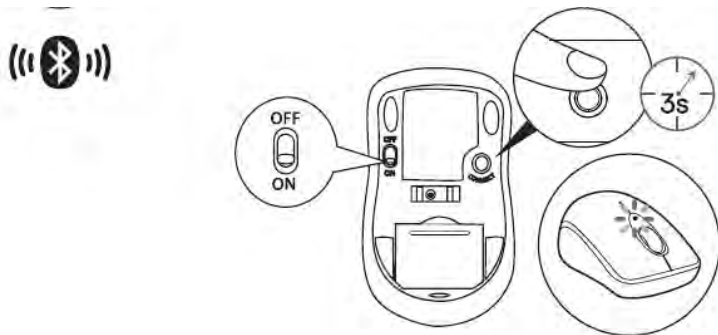
Mechanical Outline



Pairing

➤ Pairing Mode

Press and hold the power button for **3** seconds to until Blue Led keeps blinking.



➤ Connect to System

Choose the identified mouse (MT-2103 Bluetooth Mouse) and connect it with your system.

When “This device has been successfully added to this computer” window displayed, you can start use this Bluetooth mouse.

Power Off

Switch the power button to OFF.

Troubleshooting and Tips

The mouse does not operate following installation or is not recognized:

- Make sure the batteries capacity are enough.
