1.1.1.1 RF Exposure Compliance Requirement for FCC

FCC requirement: Systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy level in excess limit for maximum permissible exposure. In accordance with 47 CFR FCC Part 2 Subpart J, section 2.1091 this device has been defined as a mobile device whereby a distance of 20cm normally can be maintained between the user and the device.

Max 3.40 dBi for Bluetooth & 2.4GHz Wi-Fi, Max 1.82 dBi for 915MHz wireless.

Radio Frequency Exposure Limit

According to ANSI/IEEE C95.1-1992, the criteria listed in Table 1 shall be used to evaluate the environmental impact of human exposure to radio frequency (RF) radiation as specified in §1.1310.

> Radio Frequency Exposure Calculation Formula

$$S = \frac{PG}{4\pi R^2}$$

where: S = power density (in appropriate units, e.g. mW/cm²)

P = power input to the antenna (in appropriate units, e.g., mW)

G = power gain of the antenna in the direction of interest relative to an isotropic radiator

R = distance to the center of radiation of the antenna (appropriate units, e.g., cm)

or:

$$S = \frac{EIRP}{4\pi R^2}$$

where: EIRP = equivalent (or effective) isotropically radiated power

b) Simultaneous transmission MPE:

Per KDB 447498 D01 v06, simultaneous transmission MPE test exclusion applies when the sum of the MPE ratios for all simultaneous transmitting antennas incorporated in a host device, based on calculated or measured field strengths or power density, is \leq 1.0.

As the sum of MPE ratios for all simultaneous transmitting antennas is \leq 1.0, simultaneous transmission MPE test exclusion will be applied.

Conclusion

Therefore, the maximum calculations result of above are meet the requirement of Radio Frequency Exposure (MPE) limit.

1.1.1.2 RF Exposure Compliance Requirement for IC

The EUT shall comply with the requirement of RSS-102 section 2.5.2.

Exemption from Routine Evaluation Limits – RF Exposure Evaluation

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than $1.31 \times 10^{-2} f^{0.6834}$ W (adjusted for tune-up tolerance), where f is in MHz;

The nominal maximum conducted output power specified:

Max 3.40 dBi for Bluetooth & 2.4GHz Wi-Fi, Max 1.82 dBi for 915MHz wireless.

Note1: The e.i.r.p. for Bluetooth & Wi-Fi & 915MHz are less than the RF exposure evaluation exempted power. So, RF exposure evaluation is not required.
