Fig.1 Photograph of the SAR measurement System




Fig.2 Photograph of the Tissue Simulant liquid depth 15cm for Flat position




Fig. 3 Bottom side of the Netbook is paralleled with flat phantom, open the panel with 90 degrees, bottom side is contact with flat phantom.




Fig. 4 Bottom side of the Netbook is paralleled with flat phantom, open the panel with 90 degrees, bottom side is contact with flat phantom.




Fig.5 Right side of EUT is paralleled with flat phantom, and spacing between EUT and Phantom-in contact 15mm.




Fig. 6 Right side of EUT is paralleled with flat phantom, and spacing between EUT and Phantom-in contact 15mm.
