This notice is being sent to you because you are identified as the technical contact in the application. Review of this application is complete. Please reply to the issues below.

These questions apply to both DTS and NII composite applications under FCCID: EJE-WL0012. Only a single notice will be sent and your replies will be applied to both applications.

Q1: Confidentiality is requested for exhibit type "Internal Photo". Confidentiality for internal photos requires FCC KDB inquiry and approval. In this application the exhibit purpose is more consistent with that of exhibit type "Operational Description" with the purpose of not providing users with information about installing the module and or antenna. We will upload this exhibit as type "Operational Description" based on your confirming reply.

Q2: User manual shows WLAN as optional. Please confirm that module FCCID: PD9533ANH will always be included in products bearing FCCID: EJE-WL0012 and that only devices described in this filing will be included in products bearing FCCID: EJE-WL0012.

Q3: The SAR Report shows a UWB antenna. The label does not show "Contains: <UWB FCCID>" to indicate that a UWB device is included. Please provide a statement confirming that the UWB device will not be included in products bearing FCCID: EJE-WL0012 or provide a revised label exhibit and any other exhibits which would change if the UWB device is included.

Q4: We recommend you routinely include the type of information requested in Q2 and Q3 above in a separate letter or attestation exhibit in future filings.

The items indicated above must be submitted before processing can continue on the above referenced application. Failure to provide the requested information within 30 days of the original e-mail date may result in application dismissal and forfeiture of the filing fee. Also, please note that partial responses increase processing time and should not be submitted.
