You are listed as the Technical Contact for the above referenced TCB application. The following items need to be resolved before the review can be continued:

1. These applications for FCC ID: EJE-WL0020 and IC: 337J-WL0020 are for approval of a new Notebook computer model T5010 containing a WLAN transmitter. Please provide the following to reflect that the computer is the EUT:

- 2. The Antenna Details exhibit shows 3 Tx antennas but the Atheros WLAN Module only has 2 antenna ports and 2 Tx Chains. There is a note in the antenna exhibit indicating that Tx3 may be just a receive antenna, but the Tx module does not seem to contain a 3rd antenna connector. Please explain and/or update the antenna exhibit accordingly. Responded: Only Tx1 and Tx2 antenna data is relevant for EJE-WL0020 (337J-WL0020) applications. As the HB92 WLAN module only has two antenna ports, Tx3 antenna will never be used. See comment in the revised antenna document.
- 3. The current Confidentiality Request Letter exhibit for FCC ID: EJE-WL0020 only lists: Short-Term Confidential: External Test Setup Photos and WLAN Location Internal Photos; Confidential: WLAN Operational Description and T5010 Antenna Details.

Please note that the WLAN Block Diagram for Atheros module is tagged in the document text as CONFIDENTIAL. Additionally, the Confidential Atheros RF Schematics were submitted but the Confidentiality Request Letter does not include this exhibit to be held confidential. The Test Setup Photos and SAR setup photos were also submitted, but not listed for Short-Term Confidential inclusion. The Users Manual is also allowed to be included in Short-Term Confidentiality. Please update the Confidentiality Request Letter exhibit if you wish to include these exhibits in the full or short term confidentiality. Responded: Refer to revised FCC/IC confidential letter

- 4. The RF Test Reports No M080541 (DTS and UNII) reference IC RSS-102 Issue 1 (Provisional), but should reference RSS-102 Issue 2, February 2009. Please ensure compliance with the current version and update the test report accordingly. Responded: Refer to revised DTS and NII test reports
