The test record, data evaluation & Equipment Under Test (EUT) configurations represented herein are true and accurate accounts of the measurements of the sample's RF characteristics under the conditions specified in this report.



2 Applicable RF Exposure Limit

§ 1.1310 Radiofrequency radiation exposure limits.

(a) Specific absorption rate (SAR) shall be used to evaluate the environmental impact of human exposure to radiofrequency (RF) radiation as specified in § 1.1307(b) of this part within the frequency range of 100 kHz to 6 GHz (inclusive).

(b) The SAR limits for occupational/controlled exposure are 0.4 W/kg, as averaged over the whole body, and a peak spatial-average SAR of 8 W/kg, averaged over any 1 gram of tissue (defined as a tissue volume in the shape of a cube). Exceptions are the parts of the human body treated as extremities, such as hands, wrists, feet, ankles, and pinnae, where the peak spatial-average SAR limit for occupational/controlled exposure is 20 W/kg, averaged over any 10 grams of tissue (defined as a tissue volume in the shape of a cube). Exposure may be averaged over a time period not to exceed 6 minutes to determine compliance with occupational/controlled SAR limits.

(c) The SAR limits for general population/uncontrolled exposure are 0.08 W/kg, as averaged over the whole body, and a peak spatial-average SAR of 1.6 W/kg, averaged over any 1 gram of tissue (defined as a tissue volume in the shape of a cube). Exceptions are the parts of the human body treated as extremities, such as hands, wrists, feet, ankles, and pinnae, where the peak spatial-average SAR limit is 4 W/kg, averaged over any 10 grams of tissue (defined as a tissue volume in the shape of a cube). Exposure may be averaged over a time period not to exceed 30 minutes to determine compliance with general population/uncontrolled SAR limits.

(e) Maximum Permissible Exposure (MPE) to radiofrequency electromagnetic fields

SAR-based Exemption - §1.1307(b)(3)(i)(B)

The SAR-based exemption formula of §1.1307(b)(3)(i)(B), applies for single fixed, mobile, and portable RF sources with available maximum time-averaged power or effective radiated power (ERP), whichever is greater, of less than or equal to the threshold Pth (mW). This method shall only be used at separation distances from 0.5 cm to 40 cm and at frequencies from 0.3 GHz to 6 GHz.

$$P_{\rm th} \,({\rm mW}) = \begin{cases} ERP_{20\,\,{\rm cm}} (d/20\,\,{\rm cm})^x & d \le 20\,\,{\rm cm} \\ \\ ERP_{20\,\,{\rm cm}} & 20\,\,{\rm cm} < d \le 40\,\,{\rm cm} \end{cases}$$

where

$$x = -\log_{10}\left(\frac{60}{ERP_{20}\operatorname{cm}\sqrt{f}}\right)$$

and f is in GHz, d is the separation distance (cm)

When 10-g extremity SAR applies, SAR test exemption may be considered by applying a factor of 2.5 to the SARbased exemption thresholds.

Note:

1. Determining compliance based on the results of the compliance measurement, not taking into account measurement instrumentation uncertainty.

 Calculate the ERP of GFSK from the radiated field strength: ERP (dBm) = Radiated field strength (dBuV/m) + 20 x Log(d) - 104.77 - 2.15 d is the measurement distance, in 3 m. ERP = 67.3 + 20 x Log(3) - 104.77 - 2.15 = -30.08 dBm (0.0009817 mW) Average Power = ERP (dBm) - Antenna Gain (dBi) + 2.15 = -30.07 dBm (0.000984 mW)

Source-base time average power is below Exemption Criteria and/or Routine Evaluation MPE thresholds, therefore the device is compliant FCC RF exposure requirement.
