2. GENERAL CONCULUSION:

According to FCC KDB447498 D01, Appendix A, SAR Test Exclusion Thresholds for 100 MHz – 6 GHz and ≤ 50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)] $\cdot [\sqrt{f(GHz)}] \le 3.0$ for 1-g SAR, and ≤ 7.5 for 10-g extremity SAR, where

f(GHz) is the RF channel transmit frequency in GHz •
