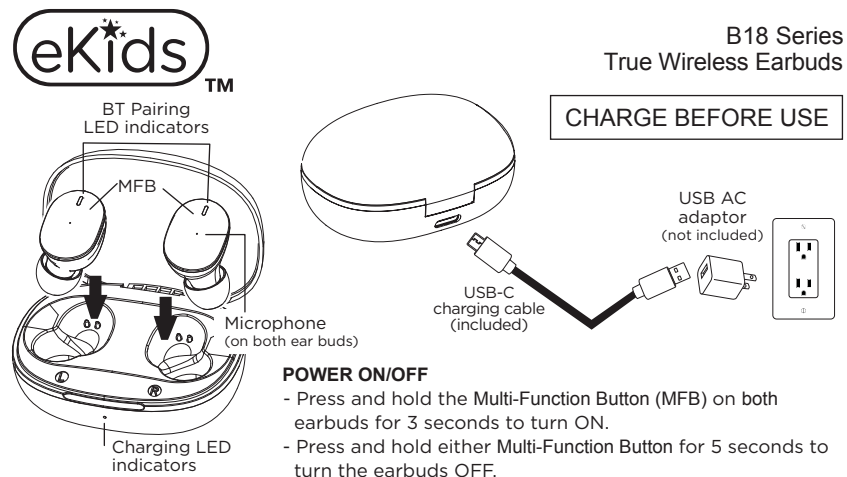

**B18 Series
True Wireless Earbuds**

CHARGE BEFORE USE

POWER ON/OFF

- Press and hold the Multi-Function Button (MFB) on both earbuds for 3 seconds to turn ON.
- Press and hold either Multi-Function Button for 5 seconds to turn the earbuds OFF.

BLUETOOTH PAIRING

- When the earbuds are ON, they will automatically enter pairing mode. (Note: The LED on one earbud will flash quickly, the LED on the other earbud will blink slowly to indicate earbuds are linked and ready to pair.) For troubleshooting, please visit www.ekids.com/b18
- Select 'ekids B18' on your Bluetooth-enabled device to connect. A voice prompt will sound to indicate pairing is complete. Earbuds will automatically connect to your Bluetooth device whenever it is in range.
- To manually pair, press the MFB on both earbuds 2 times while in pairing mode. To pair with a different device, turn Bluetooth OFF on the previously paired device, then turn the B18 earbuds OFF and back ON again to enter pairing mode. To reset Bluetooth, press the MFB on both earbuds 3 times while in pairing mode.

Play/Pause	Short press MFB
Volume Up	Press RIGHT MFB for 2 sec

Next Track	Quick double press RIGHT MFB
Previous Track	Quick double press LEFT MFB

Voice Assistant	
ON/OFF	Press MFB 3x

Charging	Flashing White LED
Fully charged	LED OFF

Case Charging	
Charging	Flashing White LED
Fully charged	White LED solid
