

#### Mode Button



### WIRELESS STEREO

### (REQUIRES 2 iBT920 SPEAKERS)

- . Pair one iBT920 unit to your device via Bluetooth. . Power on the second iBT920 unit.
- . Double press the power button on each unit
- When both units are linked, will announce "Left Channel," "Right Channel" respectively. The units will link automatically the next time they are powered on together.
- To remove wireless stereo and reset BT pairing, press and hold the Play button for 5 seconds on each unit.
