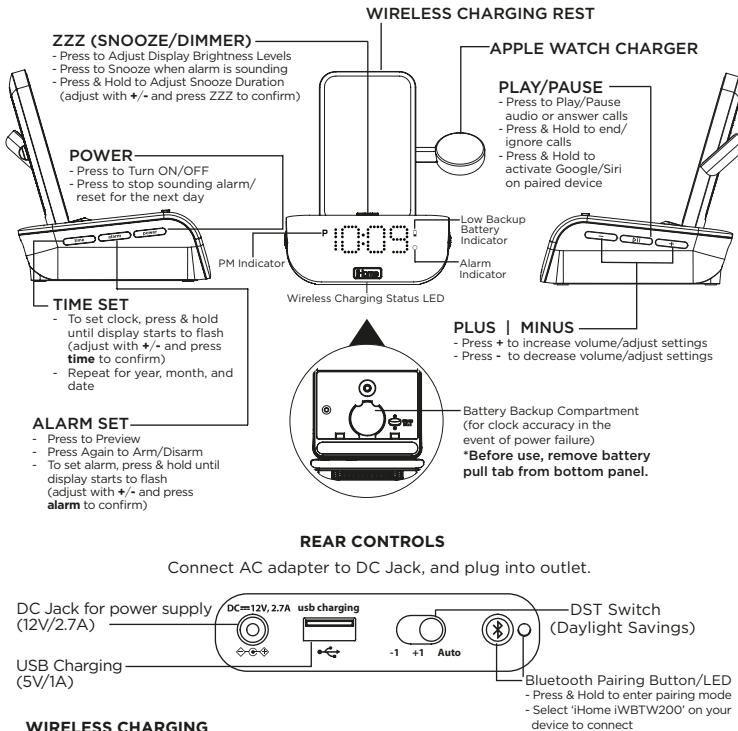

# TIMEBASE PRO+

Model: iWBWT200  
 Bluetooth Speaker + Triple Charging



**ZZZ (SNOOZE/DIMMER)**  
 - Press to Adjust Display Brightness Levels  
 - Press to Snooze when alarm is sounding  
 - Press & Hold to Adjust Snooze Duration (adjust with +/- and press ZZZ to confirm)

WIRELESS CHARGING REST

APPLE WATCH CHARGER

**PLAY/PAUSE**  
 - Press to Play/Pause audio or answer calls  
 - Press & Hold to end/ignore calls  
 - Press & Hold to activate Google/Siri on paired device

**POWER**  
 - Press to Turn ON/OFF  
 - Press to stop sounding alarm/reset for the next day

**TIME SET**  
 - To set clock, press & hold until display starts to flash (adjust with +/- and press **time** to confirm)  
 - Repeat for year, month, and date

**ALARM SET**  
 - Press to Preview  
 - Press Again to Arm/Disarm  
 - To set alarm, press & hold until display starts to flash (adjust with +/- and press **alarm** to confirm)

**PLUS | MINUS**  
 - Press + to increase volume/adjust settings  
 - Press - to decrease volume/adjust settings

**Battery Backup Compartment**  
 (for clock accuracy in the event of power failure)  
**\*Before use, remove battery pull tab from bottom panel.**

## REAR CONTROLS

Connect AC adapter to DC Jack, and plug into outlet.

DC Jack for power supply (12V/2.7A)    DC=12V, 2.7A    usb charging    DST Switch (Daylight Savings)

USB Charging (5V/1A)    Bluetooth Pairing Button/LED  
 - Press & Hold to enter pairing mode  
 - Select 'iHome iWBWT200' on your device to connect

## WIRELESS CHARGING

- Qi compatible phones (also works with plastic cases up to 3mm thick\*)

Place Qi compatible device facing forward on the charging rest. Charging status will be indicated on the LED located under the iHome badge:

Rapid blinking LED: Device is not charging (reposition device)  
 Slow blinking LED: Device is charging  
 Solid LED: Device is fully charged

**Note:** Qi status LED may continue to blink slowly (indicating charging) for iOS devices that are fully charged.  
**CAUTION:** Not all cases are wireless charging compatible. Remove phone's metal protective case before charging. Do not place magnetic or metal objects on charger during charging.

\* Some larger size phone cases may not be able to charge. (Please remove case to charge phone properly.)
