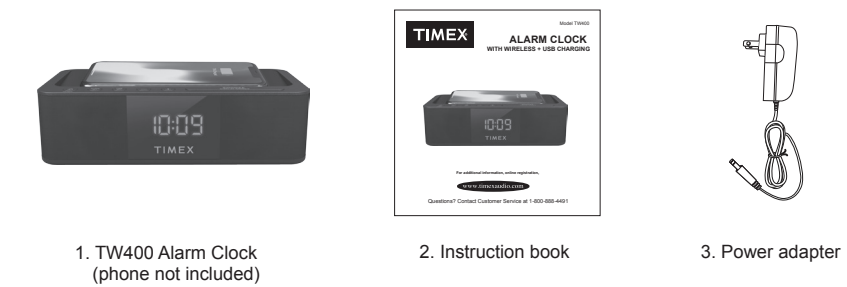

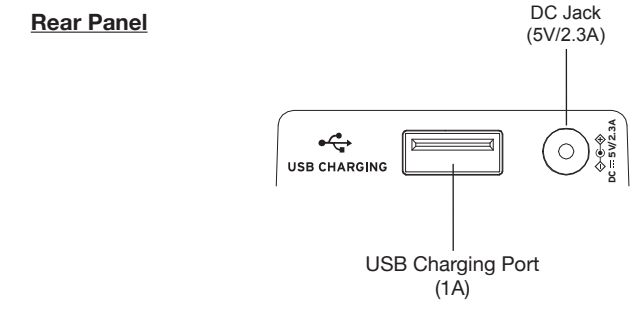
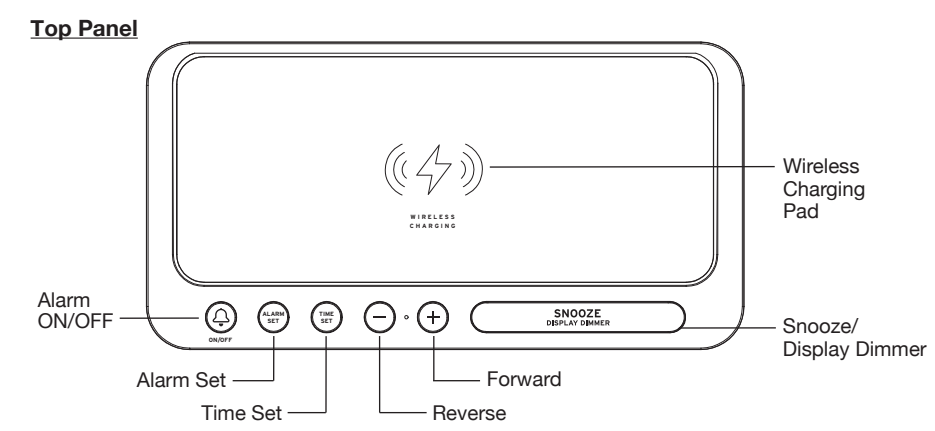
### What's in the Box

This product ships with the following items. Make sure all are present.

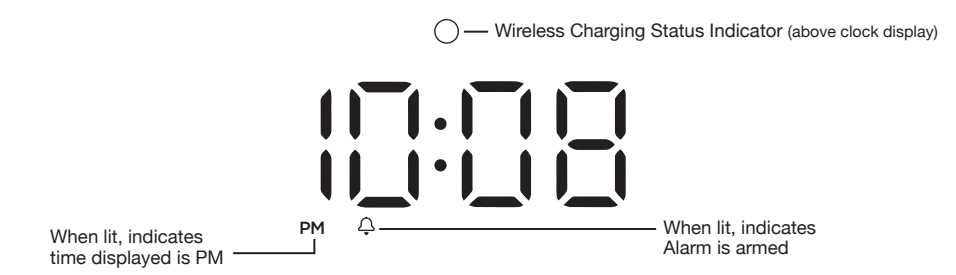


1. TW400 Alarm Clock (phone not included)      2. Instruction book      3. Power adapter

### Controls Overview



### Display



When lit, indicates time displayed is PM      When lit, indicates Alarm is armed

### Backup Battery

Your new Timex Clock includes a built-in battery backup system that will maintain the time settings during a temporary power interruption.

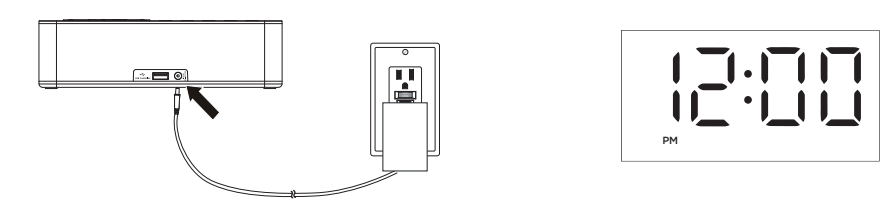


The display will turn off during a power failure, but the clock will continue to run. The alarm will NOT sound during a temporary power interruption, and will need to be reset once connected to power again.

### Set Up

#### Connecting to Power Source

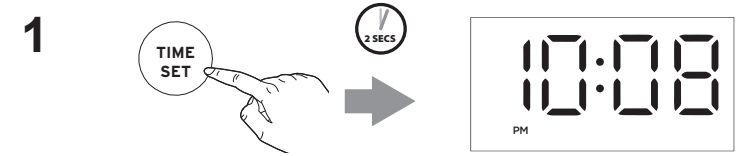
Connect the included AC adapter to the DC jack located on the back of the unit and connect the other end to a working wall outlet.



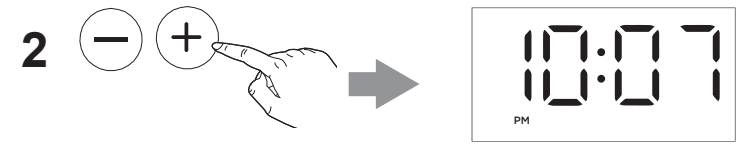
### Product Care

- Place the unit on a level surface away from sources of direct sunlight or excessive heat.
- Protect your furniture when placing your unit on a natural wood and lacquered finish. A cloth or other protective material should be placed between it and the furniture.
- Stronger cleaning agents, such as Benzene, thinner or similar materials can damage the surface of the unit.

### Setting the Time

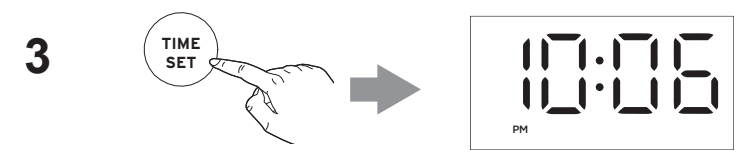


Press and hold the **Time Set Button**.



While continuing to press and hold the **Time Set Button**, press and release the **+/- Buttons** to adjust the time.

*NOTE: The PM indicator will light when the hour is set for PM. There is no AM indicator.*

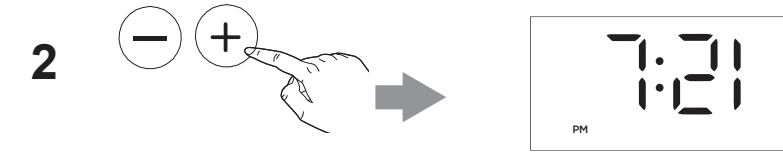


Release the **Time Set Button** to complete time setting.

### Setting and Using Alarms

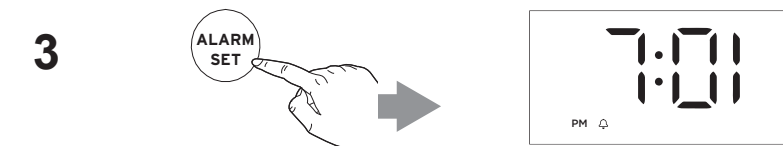


Press and hold the **Alarm Set Button**.



While continuing to press and hold the **Alarm Set Button**, press and release the **+/- Buttons** to adjust the alarm time.

*NOTE: The PM indicator will light when the hour is set for PM. There is no AM indicator.*



Release the **Alarm Set Button** to complete alarm setting. The icon will appear on the display to confirm the alarm is armed.

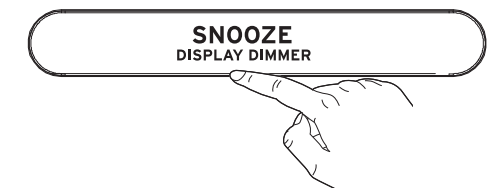
### Setting and Using Alarms (Continued)

#### RESETTING AN ALARM TO COME ON THE NEXT DAY



To silence a sounding alarm and reset it come on the next day at the same time, press and release the **Alarm Set Button**.

#### SNOOZING THE ALARM

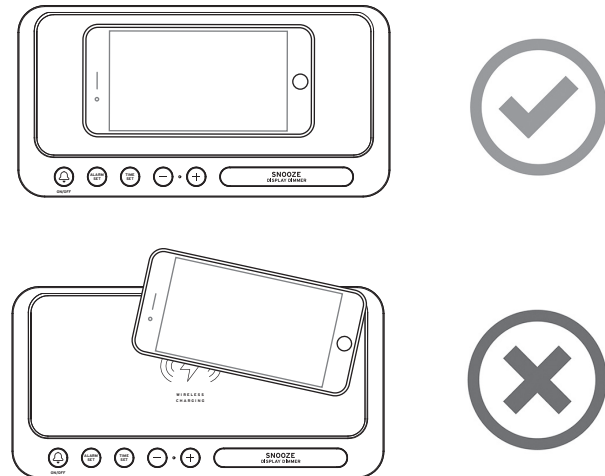


Press and release the **Snooze/Dimmer Button** when the alarm sounds to silence it for 9 minutes. The alarm icon on the display will blink while the unit is in Snooze mode. Snooze can be used several times during alarm.

## Wireless Charging

Supports:

- Qi compatible phones (also works with plastic cases up to 2mm thick)
  - AirPods with wireless charging case
- Place Qi compatible device face up on the wireless charging pad as pictured below:



### CAUTION:

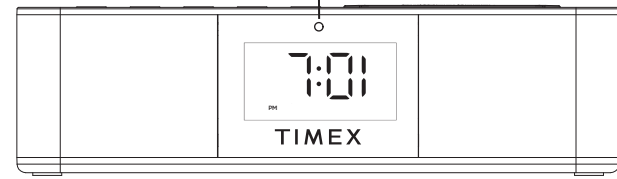
Remove metal protective or magnetic case from phone before charging. When charging phone, do not place magnetic-stripped or other metal objects on the charger. Doing so could damage the object or this unit. Qi compatible phones with metallic looking finishes will charge normally.

## Wireless Charging (Continued)

Check the wireless charging status indicator (located above the clock display) to monitor charging status:

Wireless Charging Status LED Indicator (above clock display)



**Solid blue LED:** Device is charging properly.

**Solid red LED:** Device is charged.

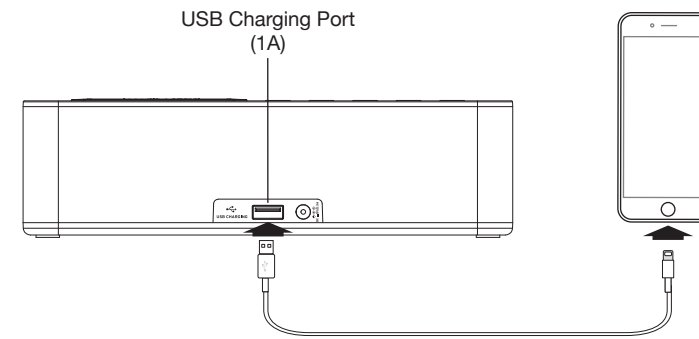
**Rapid blinking red LED:** Device is not charging properly. Reposition device.

Note: The LED indicator may continue to glow solid blue when iOS devices are fully charged.

## Charging Devices via USB Port

You can also charge your devices via the USB port located on the back of the unit.



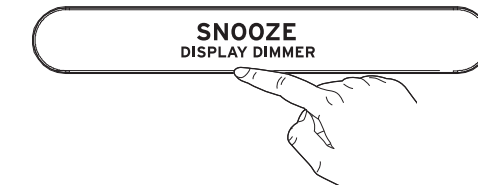
To charge devices:

- Connect the standard size end of a USB cable (not included) to the USB port on the back of the unit.
- Connect the other end to the charging port on your device.

(Make sure the unit is plugged into a working outlet in order to charge devices.)

## Display Dimmer



Press and hold the **Snooze/Dimmer Button** to toggle display brightness between high and low settings. Dimmer cannot be adjusted when alarm is sounding.

## Troubleshooting

- The unit does not power ON.**  
The unit is not connected to AC outlet, the AC outlet has no power, or is controlled by a wall switch that is "OFF". Check AC outlet and wall switch.
- Alarm does not come on.**  
The alarm time AM or PM incorrectly set, Alarm was OFF, etc. Check alarm settings.
- Unit shuts "Off" unexpectedly.**
  - a. A power surge has occurred, or the AC outlet has been disconnected.
  - b. The AC outlet may be controlled by a wall switch that is turned OFF. Check AC outlet or wall switch.
