Q#1: In the block diagram and schematics, except Bluetooth, GSP and FM transmitter, additional RDS receiver, RF remote control and MSND device are included. Please confirm their function and if they are transmitters, then please file as composite device accordingly.

Ans.: After confirm with the client, the RDS receiver, RF remote control and MSND device are RX function only, we have revised the block diagram and schematics of EUT, please see the additional file.

Q#2: As indicated in the user manual, there are no information addressed about the function of Bluetooth and FM transmitter. Please provide an updated user manual to include these related transmitters.

Q#3: As indicated in the operational description, there are two functional blocks, please explain which one is applied.
