# TW-150 Replacement Control Center

## **Product Description**

The TW-150 control center is compatible with the following systems: AS-2481TWS, AS-2482TWS, AS-6880TWS, CS-2481TWS, OB-3485, PD485, PS-4481TWS and PS-7880TWS. It is not compatible with Directed legacy 434MHz ASK or SST systems.



# **Mounting the Control Center**

Note

Once this replacement control center has been installed, all remote controls must be paired with your system. See Remote Pairing for details and follow the instructions for your remote control type.

The control center's position should be discussed with the vehicle owner prior to installation since the antenna, with built-in status LED and Valet/Program, must be visible/accessible to the customer.

The best position to locate the control center is centered high on the front windshield. It can be mounted vertically or horizontally relative to the windshield. Metallic window tint can also affect range negatively, so this should be a consideration when determining the mounting location.


After you determine the best mounting location, follow these steps:

Clean the mounting area with a quality glass cleaner or alcohol to remove any dirt or residue.

Plug the cable into the control center.

Mount the control center with double-sided tape.

Route the cable down the window pillar to the control module and plug the cable in the control module.



## **Remote Pairing**

Procedure	Confirmations
1. Setting the remote into pairing mode: Press and hold "F" button until the "PAIR MODE" appears on the remote's LCD screen.	"PAIR MODE" text is displayed on the remote's LCD screen for a period of 30 seconds.
2. Turn the key to IGN ON.	
3. Press release and then press and hold the antenna program- ming button until the LED start flashing rapidly	The Parking lights will stay ON for 20 seconds. From this point, the installer has 20seconds to complete steps 4-5.
4. Turn the key from IGN ON to IGN OFF and then OFF.	The parking light should turn OFF.
5. Press and release lock button.	The remote's LCD screen will display "PASSED "and the parking lights will start flashing to confirm successful learning of the remote. FAILED PAIRING: The remote's LCD screen will display "FAILED". First verify if the antenna is still flashing rapidly, if yes, simply redo step4. Otherwise, repeat the whole process from STEP1.
6. Press "F" button once OR leave the remote inactive for 30 seconds.	

**Note 1:** To learn the remote to a second car that has the same system, in STEP4, press the TRUNK button instead of the LOCK button.

Note2: "F" can be AUX or Orbit on the remote
