

15.231(a) Continuous transmissions such as voice, video or data transmissions are not permitted.

15.231(a)(1) A manually operated transmitter shall employ a switch that will automatically deactivate the transmitter within not more than 5 seconds after being released.

15.231(a)(2) A transmitter activated automatically shall cease transmission within 5 seconds of activation.

15.231(a)(3) Periodic transmissions at regular pre-determined intervals are not permitted. However polling or supervisory transmissions to determine system integrity of transmitters used in security or safety applications are allowed if the periodic rate of transmission does not exceed one transmission of not more than one second duration per hour for each transmitter.




