Test Results: The worst case Power Density measured was 0.51mW/cm². The Power Density limit for the EUT at its lowest operating frequency of 824.95MHz is 0.55mW/cm².

Additional Observations:

The measurement was performed on 8 radial axis at 20cm from the antenna.

The measurement was investigated on a low, middle and high channel and the worst case results are included.

The apparatus was assessed as a General Population/Uncontrolled Exposure device since it is intended to be installed in residential areas.
