We are writing in response to your request for further information concerning an application we submitted on behalf of Schlumberger Resource Management Services, Inc. ("Schlumberger") to transfer the FCC Identification number of device F9CCMM2200.

On May 4, 2001, we received e-mail correspondence from you requesting further information regarding F9CCMM2200 (Reference No.19026). Specifically, you requested that we submit an RF exposure exhibit, installation instructions into the User's Manual exhibit, antenna information including manufacturer, model number, photograph, antenna gain, and EIRP, and an exhibit showing compliance with Section 15.203 of the Commission's rules.

In response to your May 4, 2001 request, we are electronically uploading this letter and an external photograph of the device and all applicable antennas into the External Photograph exhibit folder associated with the pending application in the Office of Engineering and Technology's ("OET") application database. In addition, we are submitting an RF emissions statement into the RF Exposure Info folder in the OET application database. 

With respect to your request for installation instructions and an exhibit showing compliance with Section 15.203, as explained in the original application (Exhibit I, Letter dated 2/24/1998), F9CCMM2200 is an industrial product that is installed and maintained by trained Schlumberger personnel only. As a result, no user's manual exists for the device. In addition, Section 15.203 of the Commission's rules states that the requirements of the section do not apply for intentional radiators that must be professionally installed, such as F9CCMM2200. Accordingly, no statement regarding compliance with Section 15.203 is included.
