


Figure 1 Power output.




Figure 2 Occupied Bandwidth CW Operation.




Figure 3 Emissions at Antenna Terminal




Figure 4 Emissions at Antenna Terminal

2.1053 Field Strength of Spurious Radiation

<u>Measurements Required:</u>

Measurements shall be made to detect spurious emissions that may be radiated directly from the cabinet, control circuits, power leads, or intermediate circuit elements under normal conditions of installation and operation.

Test Arrangement:



The transmitter antenna port was connected to a 50-ohm load and placed on a wooden turntable 0.8 meters above the ground plane at a distance of 3 meters from the FSM antenna. turntable was rotated though 360 degrees to locate the position registering the highest amplitude emission. frequency spectrum was then searched for spurious emissions generated from the transmitter. Raising and lowering the FSM antenna and rotating the turntable to maximize the emission. Data was measured and recorded for the maximum amplitude of each spurious emission. A log periodic antenna was used for frequencies of 200 MHz to 5 GHz and pyramidal horn antennas were used for frequencies of 5 GHz to 40 GHz. The substitution method was used to measure the spurious Emission levels from the EUT were measured and emissions. amplitude levels were recorded. The EUT transmitter was then removed and replaced with a substitution antenna, which was powered from a signal generator. The output signal from the generator was then adjusted such that the amplitude received was the same as that previously recorded for each frequency. This step was repeated for both horizontal and vertical polarizations. The power in dBm required to produce the desired signal level was then recorded from the

The testing procedures used conform to the procedures stated in the TIA/EIA-603 document. The limits for the spurious radiated emissions are defined by the following equation.


2.1055 Frequency Stability

Measurements Required:

Pursuant to 90.213(a), Note 13, frequency stability testing is not required. However, pursuant to good engineering practices, temperature stability was measured for the operating temperature range of the unit and recorded.

- (1) Vary primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried battery equipment.
- (2) For hand carried, batteries powered equipment, reduce primary supply voltage to the battery-operating end point, which shall be specified by the manufacturer.

- With the transmitter inoperative (power Step 2: switched "OFF"), the temperature of the test chamber shall be adjusted to +25°C. After a temperature stabilization period of one hour at +25°C, the transmitter shall be switched "ON" with standard test voltage applied.
- Step 3: The carrier shall be keyed "ON", and the transmitter shall be operated unmodulated at full r.f. power output at the duty cycle for which it is rated, for duration of at least 5 minutes. The radio frequency carrier frequency shall be monitored and measurements shall be recorded.
