

The Reader/Writer Unit complies the module basic requirement (Item 1 to 8) in FCC Public Notice: Part 15 Unlicensed Modular Transmitter Approval (DA00-1407) as indicated below:

[Module basic requirement]

(1) Have its own RF shielding.: This modular transmitter has it own RF shielding. Please refer to the A1 Photo.

- (2)The modular transmitter must have buffered modulation/data inputs.: Data input to Modular transmitter is controlled as not generating excessive data speed and abnormal modulation.
