Radiated Emissions

The EUT is a placed on a turn table, which is 0.8 mabove ground plane. The turntable was rotated through 360 degrees to determ ine the position of m aximum emission level. The EUT is placed at 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. Each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.






Lowest Channel-Vertical






