


Mouse mode and Indicator LED:

- 1. 2.4G Mode (4): Red light (6) Flashes 3 times quickly.
- 2. BT1 Mode (4): Blue light (6) Flashes 3 times quickly. (Bluetooth pairing name: SlimStar 8230 / M1).
- 3. BT2 Mode (4): Red and blue lights (6) flash 3 times alternately. (Bluetooth pairing name: SlimStar 8230 / M2).
- 4. Low battery indicator (6): Red light flashes once a second.



Mouse 3 keys and buttons:

- Left Button (1): Provides traditional mouse functions like click, double click and drag.
 Magic-Roller (2): Press the [Magic-Roller] to surf the Internet and Windows
- 3. Right Button (3): Provides traditional mouse click functions.
- 4. Power button (5): ON / OFF.
- Mode switching button (4): 2.4G / BT1 / BT2.
- 6. USB receiver (7).

2 ACHy / RT1 / RT2 Mouse made switching and nairing

Operation description	
	Turn power button to ON position (5), The red indicator light (6) flashes slowly to enter 2.4G mode, and then long press Mode switching button (4) for 2 seconds into pairing mode, Insert 2.4G receiver (Dongle) (7) into USB interface of PC, After pairing successfully, the red LED goes out (6), and the bottom blue light lights up and mouse works. (Default mode: 2.4G mode (No need to pair)
Bluetooth 1 (BT1)	Press Mode switching button (4) one time, the blue indicator light (6) flashes slowly to enter BT1 mode. Under BT1 mode, Long press Mode switching button (4) for 2 seconds, the blue indicator light (6) flashes quickly to enter BT1 pairing mode [Bluetooth pairing name: SlimStar 8230 / M1], The blue indicator light (6) goes out after pairing successfully, and the bottom blue light lights up and mouse works.
Bluetooth 2 (BT2)	Press Mode switching button (4) once again, the red and blue indicator lights (6) flashes simultaneously to enter BT2 mode. Under BT2 mode, Long press Mode switching button (4) for 2 seconds, and the red and blue indicator lights (6) flash quickly to enter BT2 pairing mode [Bluetooth pairing name: SlimStar 8230 / M2]. The red and blue indicator lights (6) go out after pairing successfully, and the bottom blue light lights up and mouse works.
