

The sample was placed 0.8m above the ground plane on the OATS *. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. 

Appendix B

Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (36.875msec) never exceeds a series of 4 long (1.275msec) and 40 short (375 μ sec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 4x1.275msec+40x375 μ sec per 36.875msec=54.5% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.



Figure B [Long Pulse]





Figure B [Short Pulse]
