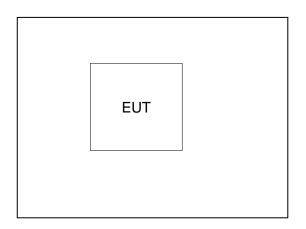

X axis, Y axis, Z axis positions:





# 8. ANTENNA REQUIREMENTS

### APPLICABLE REQUIREMENTS

### Please refer to FCC §15.203

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.
