
Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (38.64msec) never exceeds a series of 4 long (1.4msec) and 32 short (450 μ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 4x1.4 μ sec+32x450 μ sec per 28msec=58% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.



Front View of the product




Inner Circuit Top View
