Appendix B

Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (44.59msec) never exceeds a series of 4 long (1.35msec) and 40 short (450 μ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 4x1.35msec+40x450 μ sec per 44.59msec=53% duty cycle. Figure A through C show the characteristics of the pules train for one of these function.

Remarks:

Duty Cycle Correction = 20Log(0.53) =-5.5dB




Figure B [Long Pulse]





Figure B [Short Pulse]
