

99% OCCUPIED BANDWIDTH LOW CH



For example, the measurement frequency X kHz resulted in a level of Y dBuV/m, which is equivalent to Y-51.5 = Z dBuA/m, which has the same margin, W dB, to the corresponding RSS-GEN Table 6 limit as it has to be 15.209(a) limit.




