
#### **Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (80.7msec) never exceeds a series of long and short pules (12msec). Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 12msec per 80.7msec=14.9% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.




Inner Circuit Top View
