

During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. 

## **Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (81.5msec) never exceeds a series of 5 long or short (11.75 $\mu$ sec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 11.75 per 81.5msec=14.4% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.




