
EUT Operation:

The EUT was tested according to ANSI C63.4:2003. The frequency spectrum from 150kHz to 30MHz was investigated.

The maximised peak emissions from the EUT was scanned and measured for both the Live and Neutral Lines. Quasi-peak & average measurements were performed if peak emissions were within 6dB of the average limit line.

6.2 EUT Setup

The conducted emission tests were performed using the setup accordance with the ANSI C63.4:2003, The specification used in this report was the FCC Part15 Section 15.207 limits.

7.1 Measurement Uncertainty


All measurements involve certain levels of uncertainties, especially in the field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on NIS 81, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at Waltek EMC Lab is ± 5.03 dB.


7.2 EUT Setup

7.4 Test Procedure

- a) Test Procedure (below 30MHz)
 - 1. The EUT is placed on a turntable, which is 0.8m above ground plane.
 - 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.

Resolution Bandwidth 120kHz

- 3. EUT is set 3m away from the receiving antenna.
- 4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5. Repeat above procedures until the measurements for all frequencies are complete.

- b) Test Procedure (above 30MHz)
 - 1. The EUT is placed on a turntable, which is 0.8m above ground plane.
 - 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
 - 3. EUT is set 3m away from the receiving antenna, which is moved from 1m to 4m to find out the maximum emissions.
 - 4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
 - 5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
 - 6. Repeat above procedures until the measurements for all frequencies are complete.
 - 7. The radiation measurements are performed in X,Y,Z axis positioning. And all the modes was tested in the report. Only the worst case is shown in the report.

7.5 Radiated Emissions Test Result

Formula of conversion factors:the field strength at 3m was established by adding the meter reading of the spectrum analyzer (which is set to read in units of dBuV/m) to the antenna correction factor supplied by the antenna manufacturer. The antenna correction factors are stared in terms of dB. The gain of the pressletor was accounted for in the spectrum analyser meter reading.





Antenna Porlarization: Vertical




Antenna Porlarization: Horizontal




