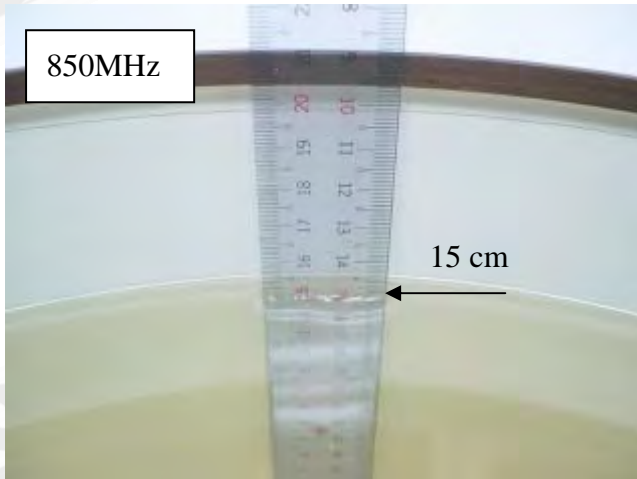


Fig.2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)

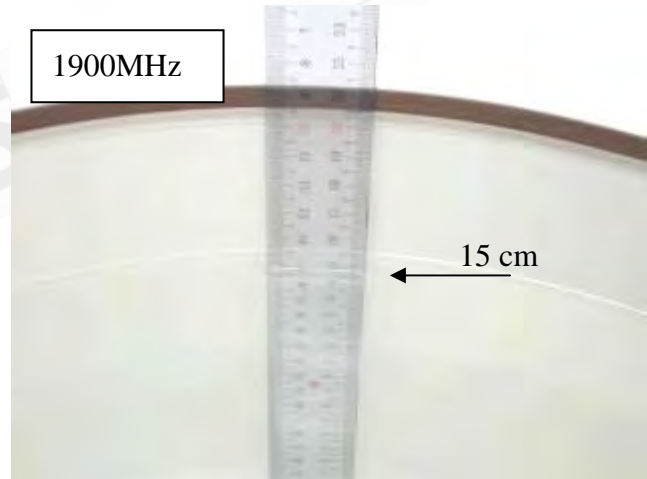


Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)

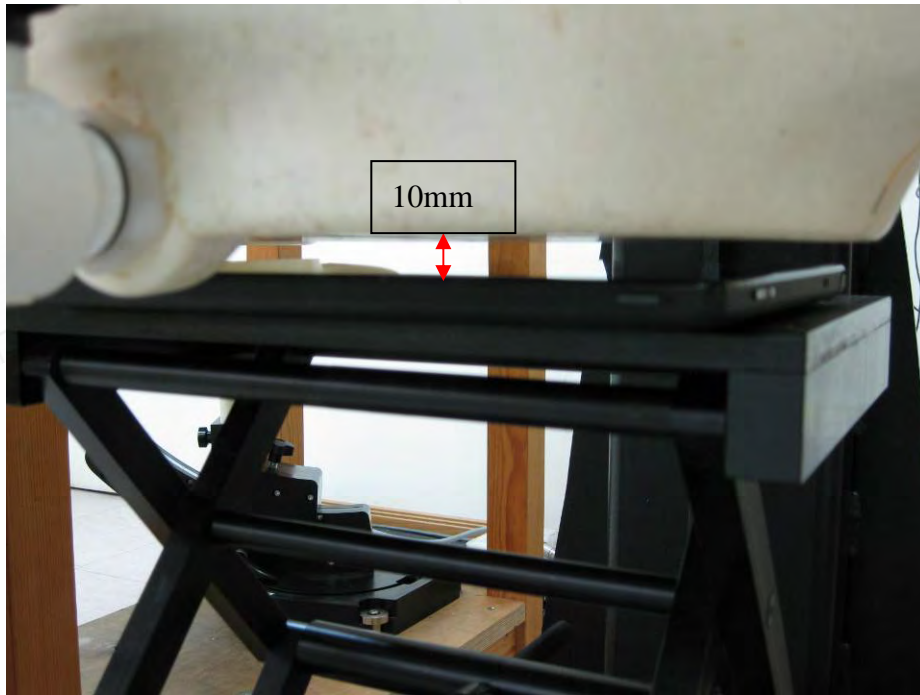


Fig.5 Front side mode _10 mm

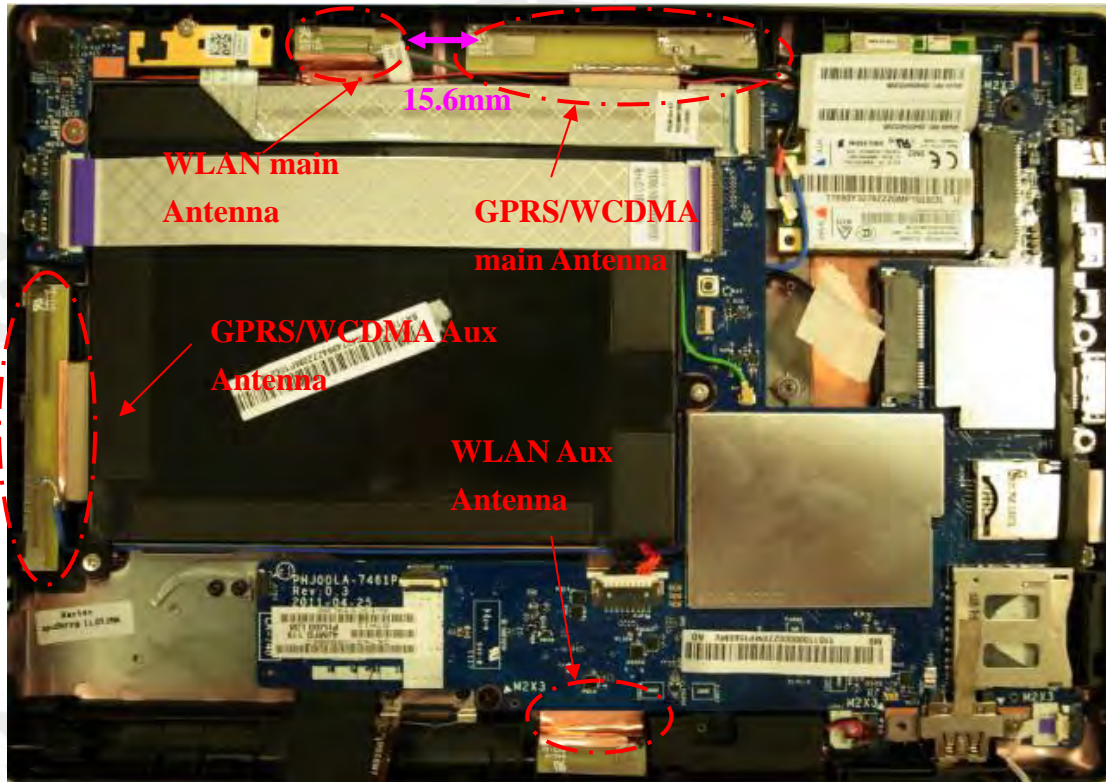


Fig.7 Back view of EUT

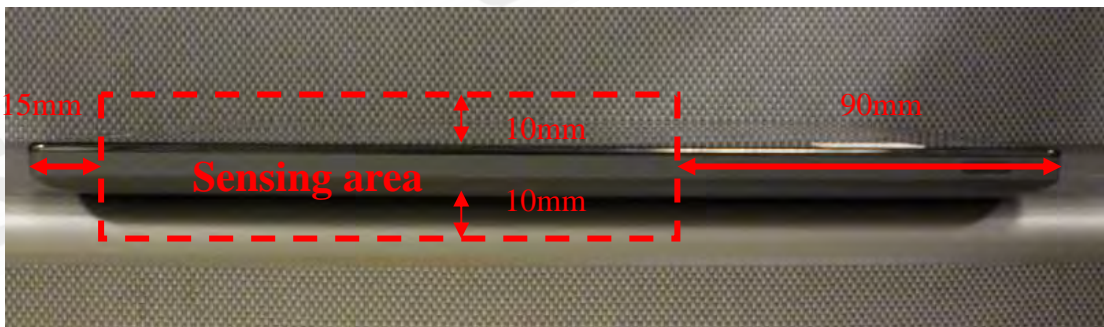
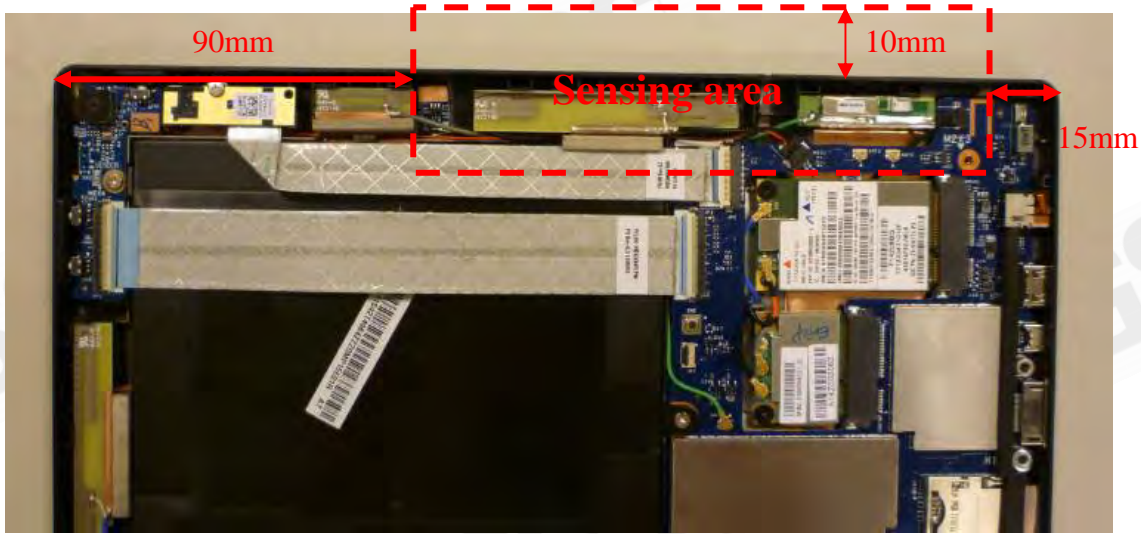
Sensing antenna (Connect to the left side of proximity sensor)
