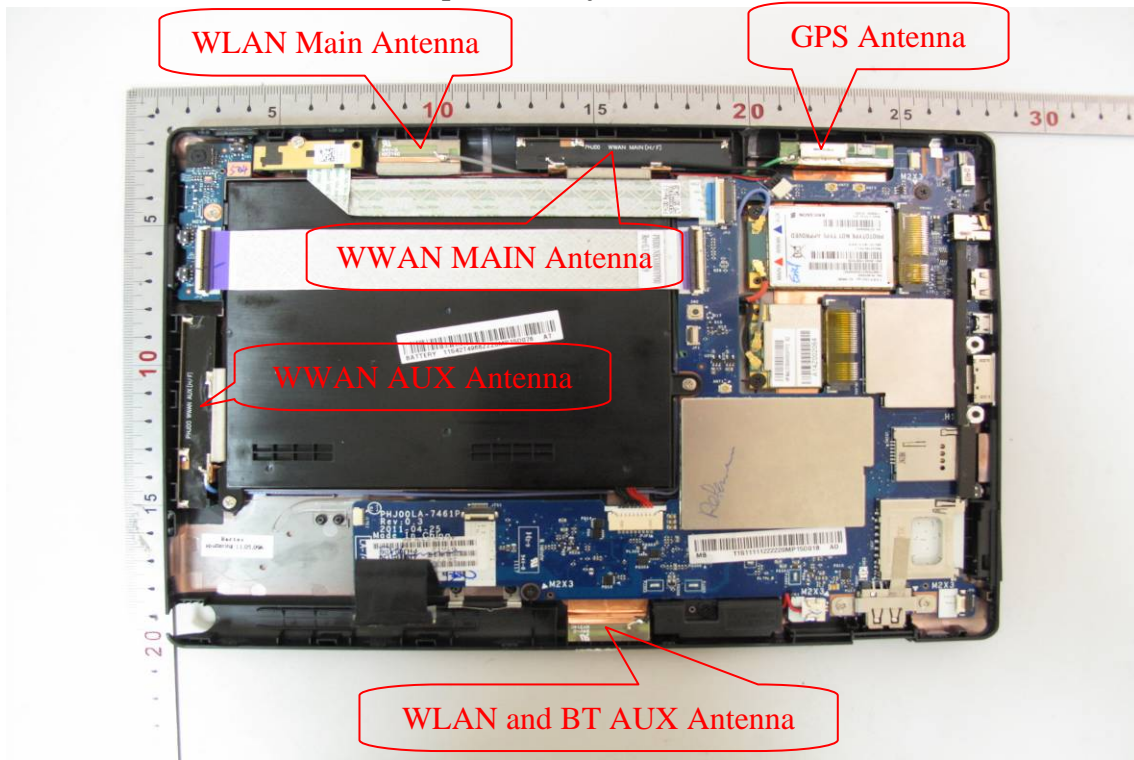

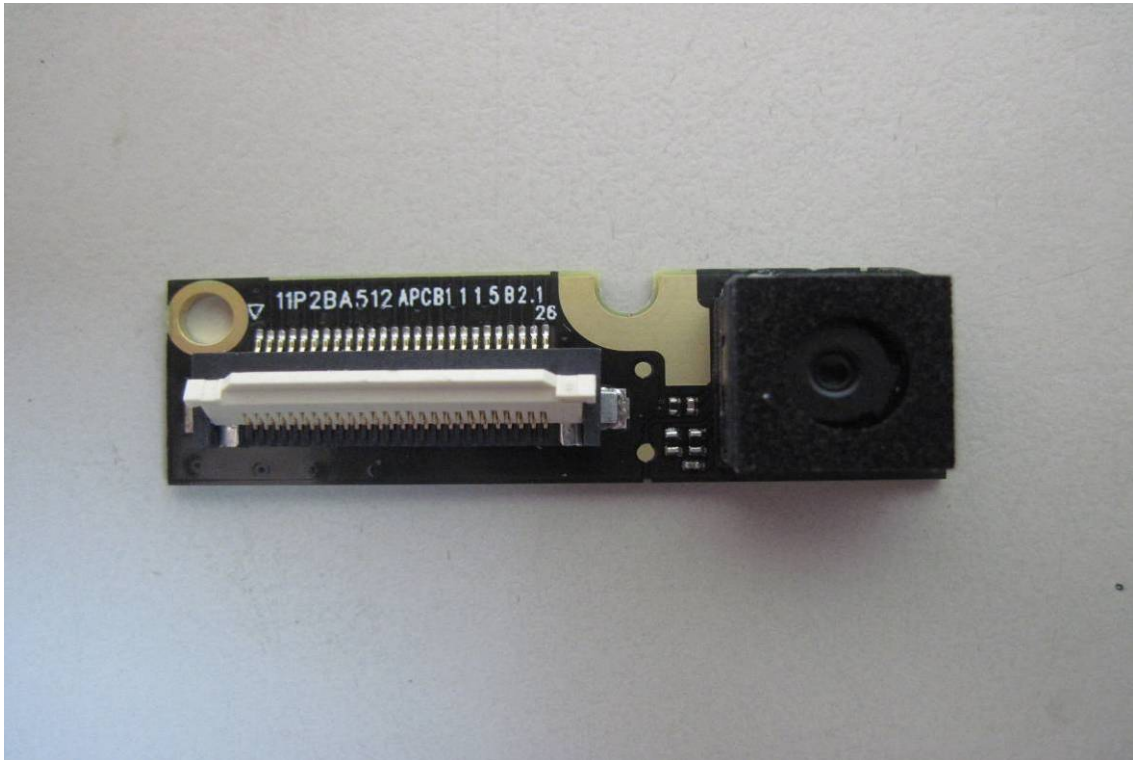

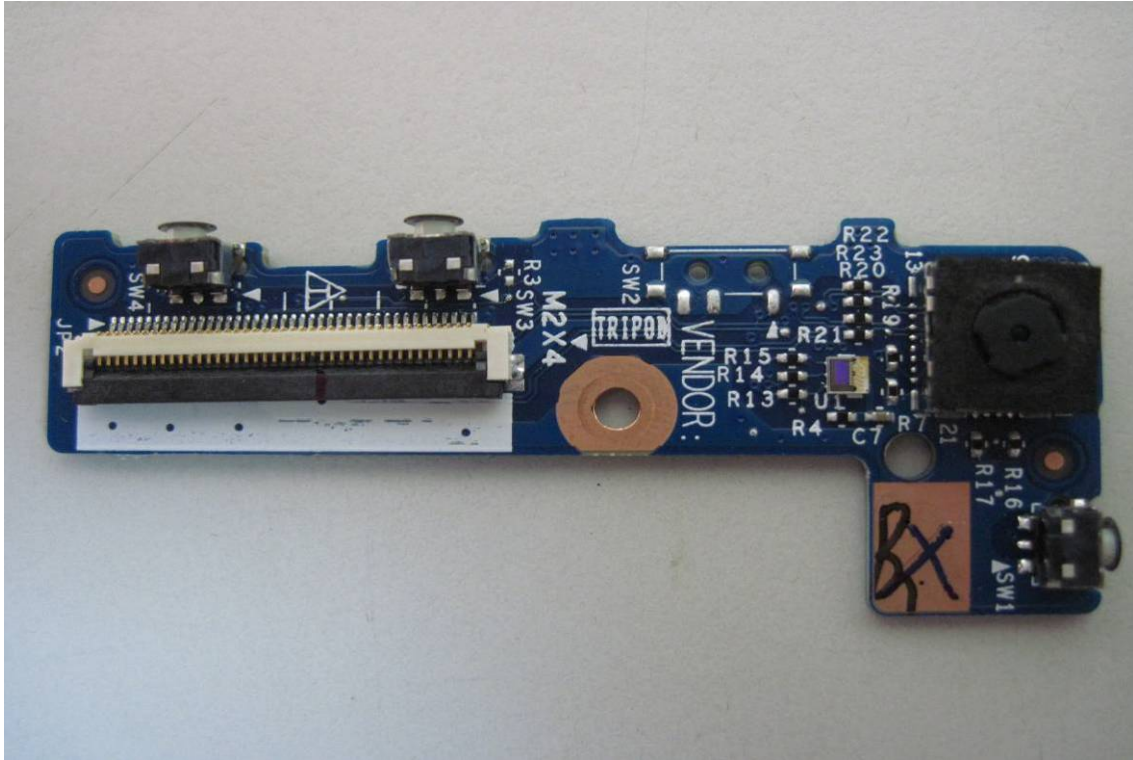

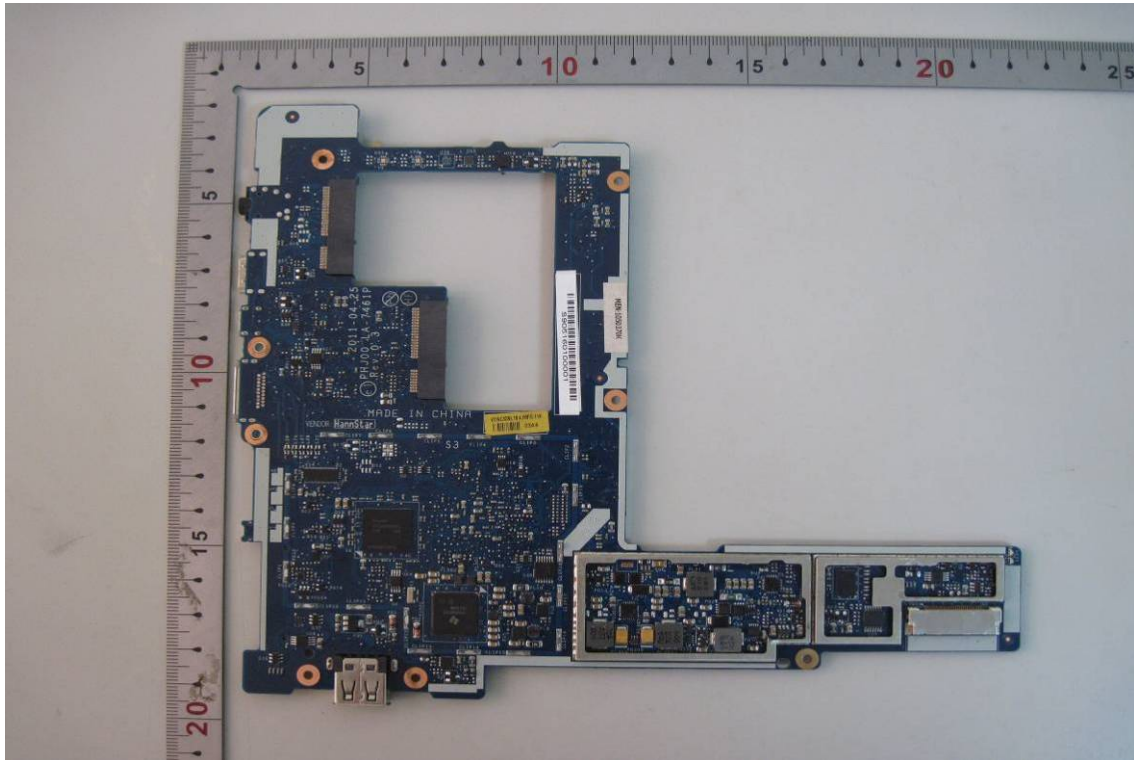

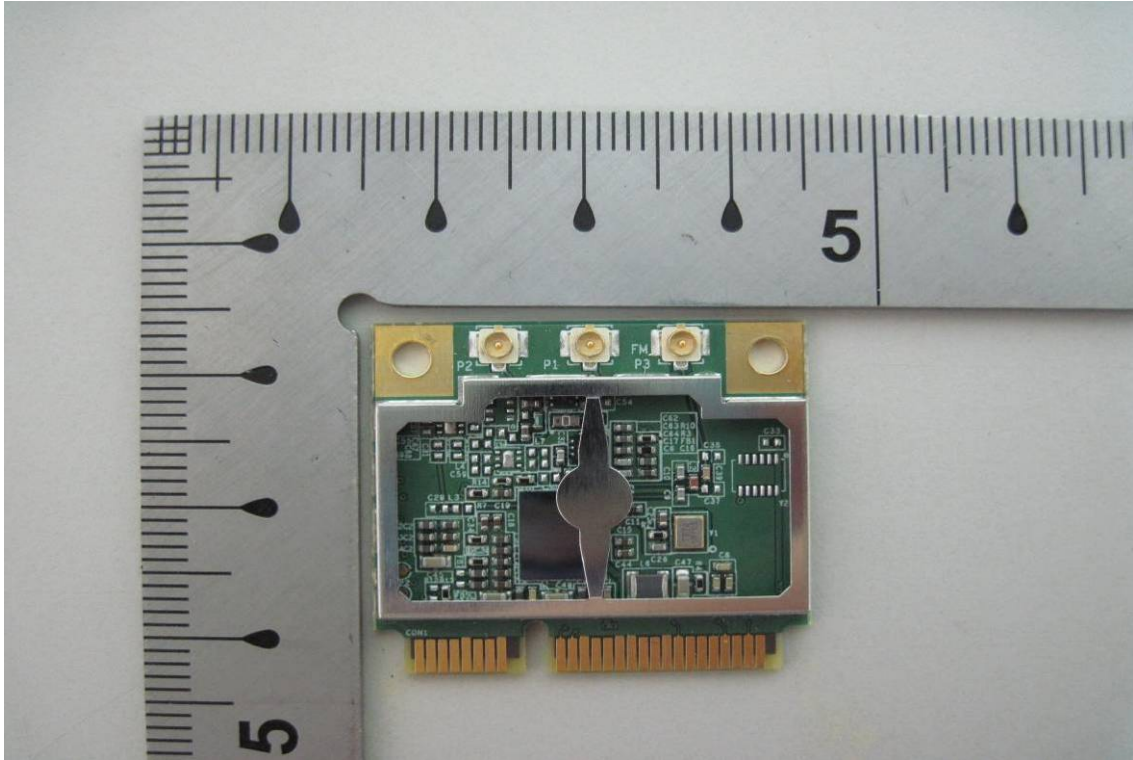

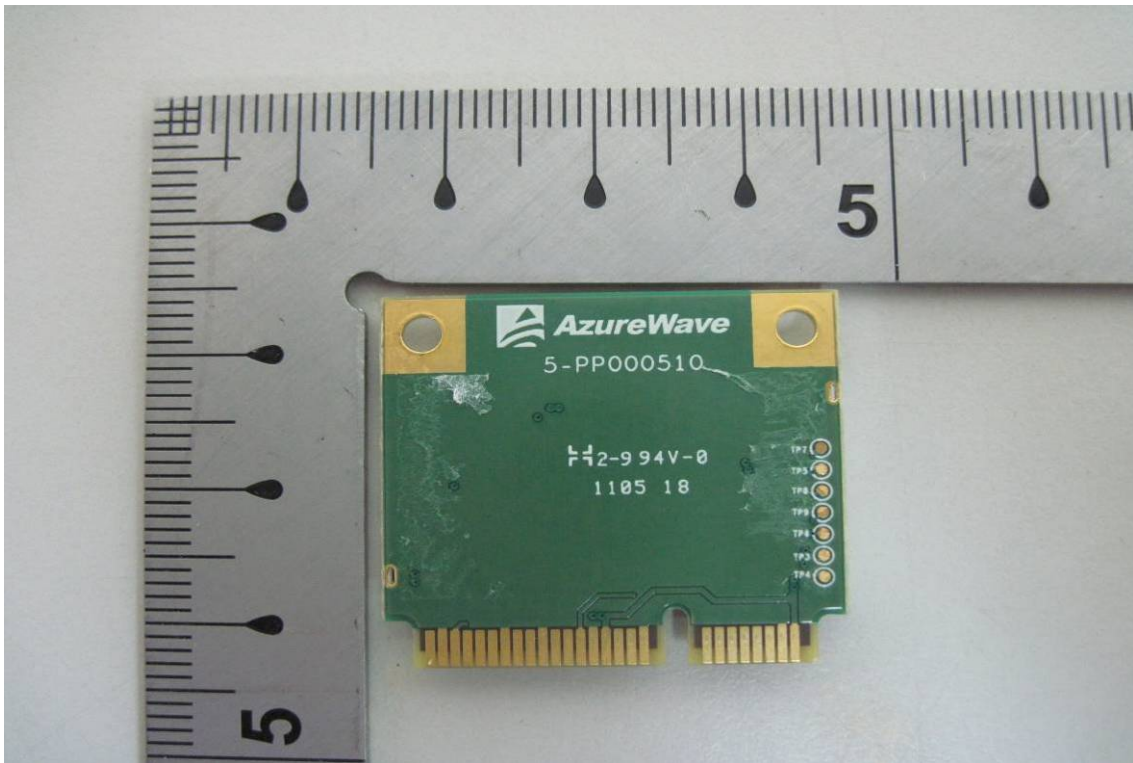

Internal View of EUT – 13

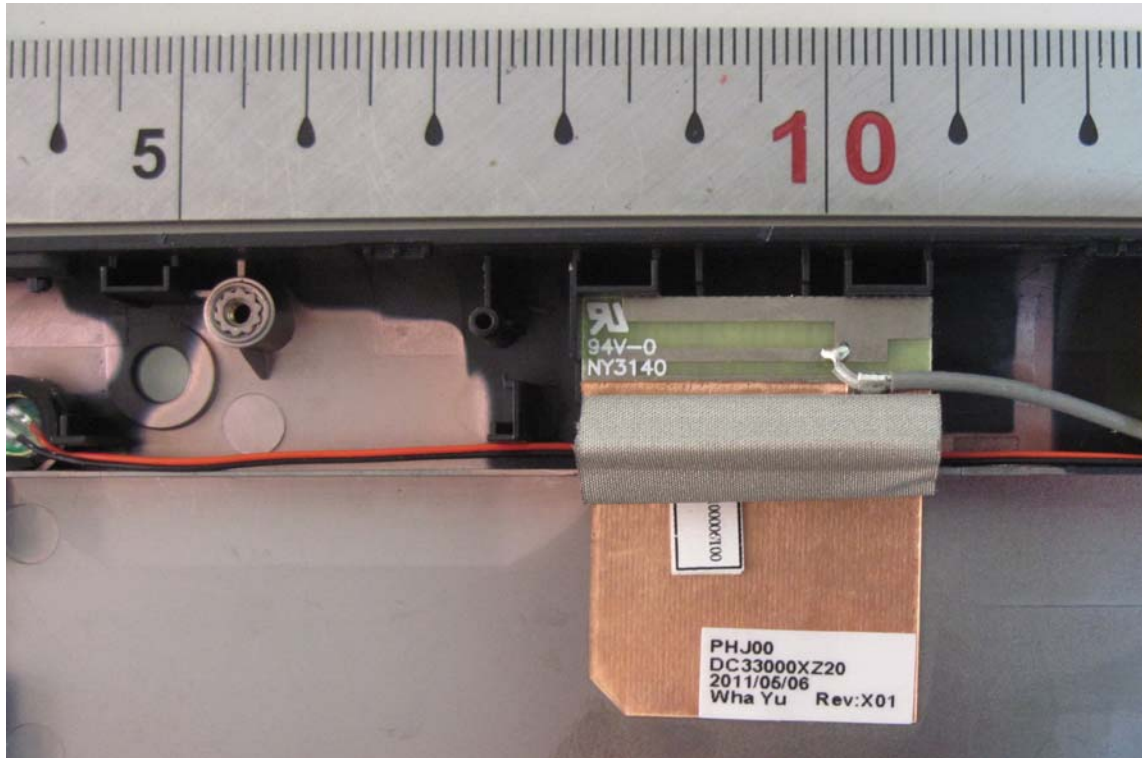

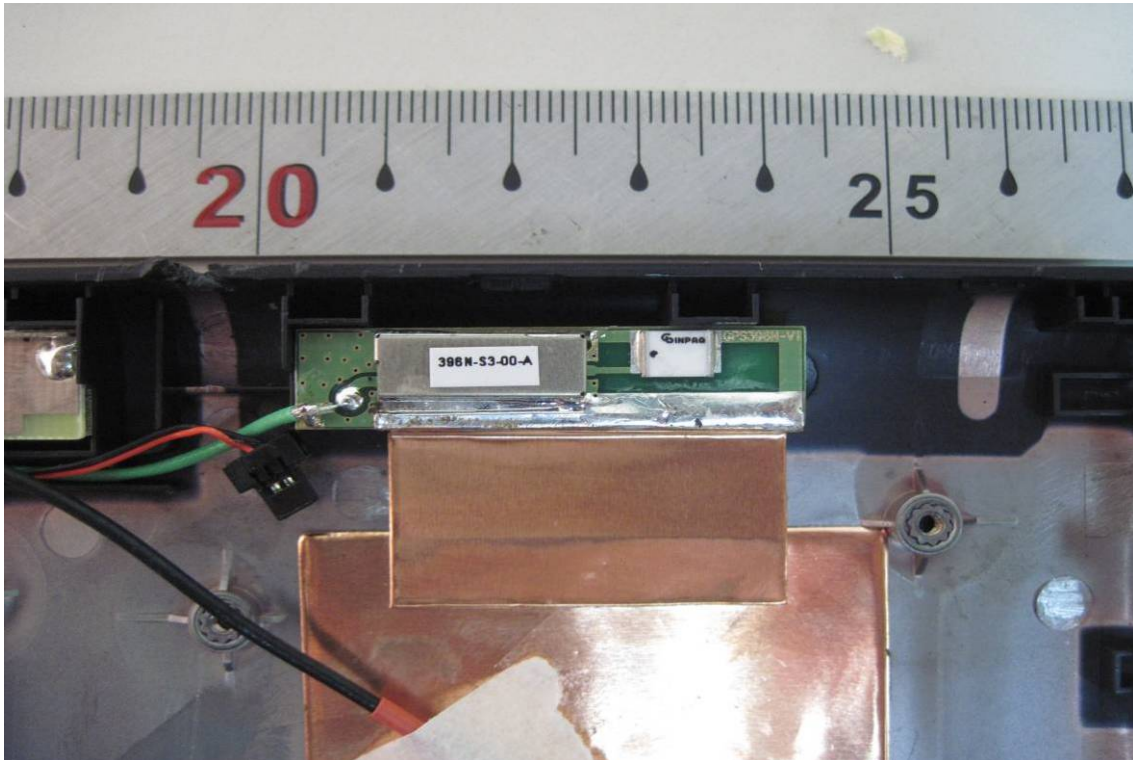
WLAN and BT AUX Antenna
