3. TEST METHODOLOGY

Both conducted and radiated testing was performed according to the procedures in ANSI C63.10: 2013 Radiated testing was performed at an antenna to EUT distance 3 meters.

The tests documented in this report were performed in accordance with ANSI C63.10: 2013 and FCC CFR 47 Part 15.207, 15.209 and 15.407, RSS-GEN Issue 2, and RSS-210 Issue 8.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed for RF field strength measurement to meet the Commissions requirement, and is operated in a manner intended to generate the maximum emission in a continuous normal application.

3.2 EUT EXERCISE

The EUT is operated in the engineering mode to fix the Tx frequency for the purposes of measurement.

According to its specifications, the EUT must comply with the requirements of Section 15.407 under the FCC Rules Part 15 Subpart E.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is positioned at 0.8 m above the ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.10: 2013, the conducted emission from the EUT is measured in the frequency range between 0.15 MHz and 30MHz, using the CISPR Quasi-Peak detector mode.

Radiated Emissions

The EUT is placed on the turntable, which is 0.8 m above the ground plane. The turntable is then rotated for 360 degrees to determine the proper orientation for the maximum emission level. The EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission level. And, each emission is to be maximized by changing the horizontal and vertical polarization of the receiving antenna. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.10: 2013.

(b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.



3.5 DESCRIPTION OF TEST MODES

The EUT (Model: TP00064B) had been tested under operating condition.

The EUT is a 2x2 configuration spatial MIMO (2Tx & 2Rx) without beam forming function. The 2x2 configuration is implemented with three outside TX & RX chains (Chain 0 and Chain 1).

Software used to control the EUT for staying in continuous transmitting mode was programmed.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz, which worst case was in normal link mode only.

UNII Band I:

IEEE 802.11a for 5180 ~ 5240MHz:

Channel Low (5180MHz), Channel Mid (5220MHz) and Channel High (5240MHz) with 6Mbps data rate were chosen for full testing.

IEEE 802.11n HT 20 MHz for 5180 ~ 5240MHz:

Channel Low (5180MHz), Channel Mid (5220MHz) and Channel High (5240MHz) with 6.5Mbps data rate were chosen for full testing.

IEEE 802.11n HT 40 MHz Channel for 5190 ~ 5230MHz:

Channel Low (5190MHz) and Channel High (5230MHz) with 13.5Mbps data rate were chosen for full testing.

IEEE 802.11ac VHT 80 MHz Channel for 5210MHz:

Channel Low(5210MHz) with 29.3Mbps data rate were chosen for full testing.

UNII Band II:

IEEE 802.11a for 5260 ~ 5320MHz:

Channel Low (5260MHz), Channel Mid (5280MHz) and Channel High (5320MHz) with 6Mbps data rate were chosen for full testing.

IEEE 802.11n HT 20 MHz for 5260 ~ 5320MHz:

Channel Low (5260MHz), Channel Mid (5280MHz) and Channel High (5320MHz) with 6.5Mbps data rate were chosen for full testing.

IEEE 802.11n HT 40 MHz for 5270 ~ 5310MHz:

Channel Low (5270MHz) and Channel High (5310MHz) with 13.5Mbps data rate were chosen for full testing.

IEEE 802.11ac VHT 80 MHz for 5290MHz:

Channel Low (5290MHz) with 29.3Mbps data rate were chosen for full testing.



UNII Band III:

IEEE 802.11a for 5500 ~ 5700MHz:

Channel Low (5500MHz), Channel Mid (5580MHz) and Channel High (5700MHz) with 6Mbps data rate were chosen for full testing.

IEEE 802.11n HT 20 MHz for 5500 ~ 5700MHz:

Channel Low (5500MHz), Channel Mid (5580MHz) and Channel High (5700MHz) with 6.5Mbps data rate were chosen for full testing.

IEEE 802.11n HT 40 MHz for 5510 ~ 5670MHz:

Channel Low (5510MHz), Channel Mid (5590MHz) and Channel High (5670MHz) with 13.5Mbps data rate were chosen for full testing.

IEEE 802.11ac VHT 80 MHz for 5530 ~ 5690MHz:

Channel Low (5530MHz), and Channel High (5670MHz) with 29.3Mbps data rate were chosen for full testing.

The field strength of spurious emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis). The worst emission was found in stand-up position (Z axis) and the worst case was recorded.

Test items for conducted and radiated emission were performed for report. Other testing data please refer to module (Brand: Lenovo, Model: Tablet Computer, FCC ID: GKR-TP00064B, IC: 2533B-TP00064B)



4. INSTRUMENT CALIBRATION

4.1 MEASURING INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipment, which is traceable to recognized national standards.

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

5.3 LABORATORY ACCREDITATIONS AND LISTING

The test facilities used to perform radiated and conducted emissions tests are accredited by American Association for Laboratory Accreditation Program for the specific scope accreditation under Lab Code: 0824-01 to perform Electromagnetic Interference tests according to FCC Part 15 and CISPR 22 requirements. In addition, the test facilities are listed with Industry Canada, Certification and Engineering Bureau, IC 2324G-1 for 3M Semi Anechoic Chamber A, 2324G-2 for 3M Semi Anechoic Chamber B.

7.1 MAXIMUM CONDUCTED OUTPUT POWER


According to §15.407(a),

- (1) For the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed the lesser of 250 mW, where B is the 26 dB emission bandwidth in MHz.
- (2) For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW, where B is the 26 dB emission bandwidth in MHz.

If transmitting antennas of directional gain greater than 6dBi are used, both the peak transmit power and the peak power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

Specified Limit of the Maximum Output PowerTest Configuration

The EUT was connected to a spectrum analyzer through a 50Ω RF cable.



TEST PROCEDURE

The transmitter output is connected to the Power Meter. The Power Meter is set to the Average power detection.

7.4 POWERLINE CONDUCTED EMISSIONS

<u>limit</u>

According to \$15.207(a), except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 μ H/50 ohms line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

- 1. The EUT was placed on a table, which is 0.8m above ground plane.
- 2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 3. Repeat above procedures until all frequency measured were complete.



test results

The initial step in collecting conducted data is a spectrum analyzer peak scan of the measurement range. Significant peaks are then marked as shown on the following data page, and these signals are then quasi-peaked.


