Modifications of New model:

- gets a backpack to cover Fingerprint, Smartcard, Imager and digital camera functions. The backpack has no intentional radiator.
- backpack is affixed by manufacturer and cannot be unfasten by end user
- voice function is longer supported.
- based on design, device can be used hand held only.
- no hardware changes on existing device, but additional hardware.
- PCB layouts, transmitters modules, antennas and their position, have not been changed
