Mike wrote:

1) FCC ID label should not have FCC DoC logo. Wireless mouse is an intentional radiator which does not subject to FCC DoC procedures. Please provide revised FCC ID label format without FCC DoC logo.

2) User manual does not contain information required under section 15.21 of FCC rules, please provide revised user manual to comply this requirements.

By comparing Wireless keyboard and Wireless Mouse, I found some problems in the test report. Please ask Engineering to answer the questions:

1) Please provide detail antenna factor and cable loss information used to calculate correction factor. Please provide detail information on the following frequencies:
