#### **6.2 TEST PROCEDURES** (please refer to measurement standard)

#### 1) Sequence of testing 9 kHz to 30 MHz

#### **Setup:**

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### **Pre measurement:**

- --- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- --- The antenna height is 0.8 meter.
- --- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

#### **Final measurement:**

- --- Identified emissions during the pre measurement the software maximizes by rotating the turntable position (0  $^{\circ}$ to 360  $^{\circ}$ ) and by rotating the elevation axes (0  $^{\circ}$ to 360  $^{\circ}$ ).
- --- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.
- --- The final levels, frequency, measuring time, bandwidth, turntable position, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the pre measurement and the limit will be stored.

#### 2) Sequence of testing 30 MHz to 1 GHz

#### **Setup:**

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a table with 0.8 m height is used, which is placed on the ground plane.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### Pre measurement:

- --- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height changes from 1 to 3 meter.
- --- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

#### **Final measurement:**

- --- The final measurement will be performed with minimum the six highest peaks.
- --- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm 45$  °) and antenna movement between 1 and 4 meter.
- --- The final measurement will be done with QP detector with an EMI receiver.
- --- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

## 3) Sequence of testing 1 GHz to 18 GHz

#### **Setup:**

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

#### Pre measurement:

- --- The turntable rotates from 0 ° to 315 ° using 45 ° steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height scan range is 1 meter to 2.5 meter.
- --- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

#### **Final measurement:**

- --- The final measurement will be performed with minimum the six highest peaks.
- --- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position ( $\pm 45$ °) and antenna movement between 1 and 4 meter. This procedure is repeated for both antenna polarizations.
- --- The final measurement will be done in the position (turntable, EUT-table and antenna polarization) causing the highest emissions with Peak and Average detector.
- --- The final levels, frequency, measuring time, bandwidth, turntable position, EUT-table position, antenna polarization, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the pre measurement with marked maximum final measurements and the limit will be stored.

# 4) Sequence of testing above 18 GHz Setup:

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 1 meter.
- --- The EUT was set into operation.

#### Pre measurement:

--- The antenna is moved spherical over the EUT in different polarisations of the antenna.

#### **Final measurement:**

- --- The final measurement will be performed at the position and antenna orientation for all detected emissions that were found during the premeasurements with Peak and Average detector.
- --- The final levels, frequency, measuring time, bandwidth, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.

NOTE: The resolution bandwidth of test receiver/spectrum analyzer is 1MHz and the video bandwidth is 3MHz for RMS Average (Duty cycle < 98%) for Average detection (AV) at frequency above 1GHz, then the measurement results was added to a correction factor (10 log(1/duty cycle)).




Figure 1. 9KHz to 30MHz radiated emissions test configuration




Figure 2. 30MHz to 1GHz radiated emissions test configuration




Figure 3. Above 1GHz radiated emissions test configuration

#### 9.2 TEST PROCEDURES

- 1) The EUT is placed on a turntable, which is 1.5m above the ground plane.
- 2) The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3) EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission.
- 4) Set the spectrum analyzer in the following setting in order to capture the lower and upper band-edges of the emission:
  - a) PEAK: RBW=1MHz / VBW=1MHz / Sweep=AUTO
  - b) AVERAGE: RBW=1MHz / VBW=1/T / Sweep=AUTO
- 5) Repeat the procedures until all the PEAK and AVERAGE versus POLARIZATION are measured.


