

button function:



A: Display

- B: Switch the Mode(Bluetooth/Radio)
- C: Long press decreased the volume, quick press skip to previous song/previous channel.
- D: Long press power on/off, quick press play/pause/searching the channel.
- E: Long press increased the volume, quick press skip to next song/next channel.
- F: Light Control Button
- H: USB charging port

Function:

1: Bluetooth connecting

When turned on, the blue lights flash quickly, enter into pairing status, then you can open the Bluetooth function, start searching.

When found "AR6001", Bluetooth paired successfully. If needs to use the password, please try to use "0000", press confirm, waiting for connecting.

When paired the Bluetooth successfully, the blue light flashes slowly, now you can enjoy the music.

Remarks: Multimedia devices have memory function, after the first successful connection, the second connection does not need to set up again, the headset will automatically connect to the last device has been connected before.

2: Radio Mode

Press B button to switch the radio, press D button to search the channel, after searching and saved, press C, E button to switch the frequency.

3: Charging

When the battery is low, there will be a tone, you can use a USB port to charge, during the charging , the red light is on, charging full, the red light is off.
