
In the Box



Pairing the Headphones

- 1. Long press the [也] button to power ON. The LED indicator will flash RED and BLUE.
- 2. Set your mobile device to search for Bluetooth devices. Select **SBT641-HP** from the list of found devices.
- 3. After a successful pairing, a tone will be heard indicating that the device is paired and the LED indicator will slowly flash BLUE.

On an iOS or Android Device Go to Settings -> Bluetooth



Using the Headphones



Powering ON/OFF

- •To turn the headphones ON, long press the [也] button. A tone will be heard, indicating that the headphones are powered ON.
- •To turn the headphones OFF, long press the [也]

If not in-use for 3 minutes, the headphones will go into sleep mode to conserve power. Press Power button on the earcup to wake the headphones up.

Adjusting Volume

- Long press the [+] button to increase volume. A tone will be heard if you attempt to increase the volume past maximum level.
- Long press the [—] button to decrease volume.

To enjoy music on your headphones, make sure you are paired to a Bluetooth-enabled device. Once paired, you can control media playback and volume adjustment with the controls on your paired device on with the headphones.

Playing/Pausing Media


- •To pause media playback, press the [ტ] button.
- To resume media playback, press the [♂] button, again.

• To skip to the previous track, quick press the [—] button. • To skip to the next track, quick press the [+] button.

Answering/Ending Phone Calls

- To answer an incoming phone call, quick press the [ტ] button.
- To end a phone call, quick press the [⊕] button, again. • To reject an incoming phone call, long press the [也]
- button for 2 seconds.

Location of Controls



(Side of Right Earcup)

- 1. [+] Button:
 - Long press Increase volume Quick press - Skip to next track
- Long press Power ON/OFF, reject incoming phone call Quick press - Play/pause media playback, Answer/end phone calls
- 3. [—] Button:
 - Long Press Decrease volume
 - Quick Press Skip to previous track



Charging the Headphones

To charge the headphones, attach the small connector
To use the headphones with a wired device, attach the device, or a **5V USB adapter** (not included) and plug into the headphone jack on your media-playing device.

The LED indicator will turn **RED** while charging and turn **BLUE** when charged.




NOTE: A voice will be heard indicating that power is low when the headphones need to be recharged.
