GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Shenzhen Linpa Technology Co.*, *Ltd*'s product, model number: *LEB13 (FCC ID:GTOLEB13)* or the "EUT" in this report was a *BT EARPHONE*, which was measured approximately: 71.5 cm (L) x 3.1 cm (W) x 2.2 cm (H), rated with input voltage: DC 3.7 V rechargeable Li-ion battery or DC5.0 V from USB port.

Note: The product, series model LEB13 and PBT90 are identical schematics, and the model LEB13 which was selected for fully testing, they are just different for model number, which was explained in the attached declaration letter.

Objective

This report is prepared on behalf of *Shenzhen Linpa Technology Co., Ltd* in accordance with Part 2-Subpart J, Part 15- Subparts A, B and C of the Federal Communication Commissions rules.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, and section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed and Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz, and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.



The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the user of a standard antenna jack or electrical connector is prohibited. The structure and application of the EUT were analyzed to determine compliance with section §15.203 of the rules. §15.203 state that the subject device must meet the following criteria:

- a. Antenna must be permanently attached to the unit.
- b. Antenna must use a unique type of connector to attach to the EUT. Unit must be professionally installed, and installer shall be responsible for verifying that the correct antenna is employed with the unit.

The EUT has a PCB antenna arrangement for BT, which was permanently attached and the gain was 0 dBi, fulfill the requirement of this section. Please refer to the internal photos.




Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-2:2011, the expended combined standard uncertainty of radiation emissions at Bay Area Compliance Laboratories Corp. (Shenzhen) is 5.91 dB for 30MHz-1GHz, and 4.92 dB for above 1GHz. And this uncertainty will not be taken into consideration for the test data recorded in the report.

Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All final data was recorded in Quasi-peak detection mode for 30 MHz-1GHz, peak and average detection modes for above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:


Middle Channel






RF Output Power, Low Channel







In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. - 3. Set RBW to 100 kHz and VBW of spectrum analyzer to 300 kHz with a convenient frequency span including 100 kHz bandwidth from band edge.
- 4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
- 5. Repeat above procedures until all measured frequencies were complete.






