#### 4.2.3 TEST PROCEDURES

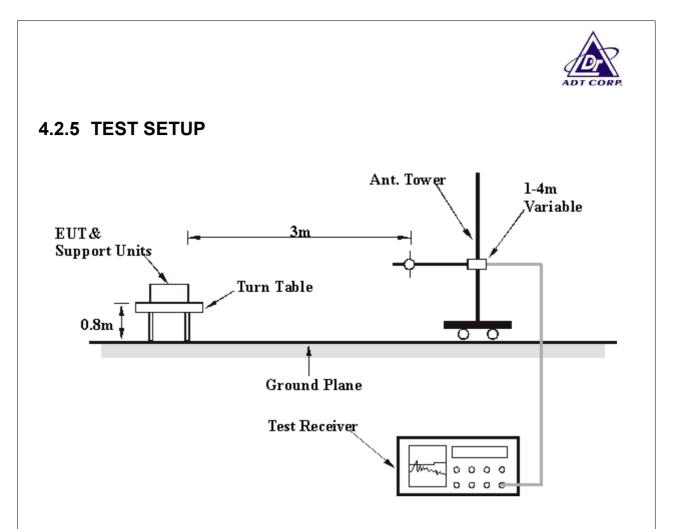
- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi- anechoic. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions would be re-tested one by one using peak, quasi-peak method or average method as specified and then reported in data sheet.

#### NOTE:

- 1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120kHz for Quasi-peak detection at frequency below 1GHz.
- 2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection (PK) at frequency above 1GHz.
- 3. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 10 Hz for Average detection (AV) at frequency above 1GHz.

#### 4.3.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured by spectrum analyzer with 100kHz RBW and 100kHz VBW. The 6dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 6dB.



#### 4.4.3 TEST PROCEDURES

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Turn on the EUT and connect it to measurement instrument. Then set it to any one convenient frequency within its operating range. Set a reference level on the measuring instrument equal to the highest peak value.
- 3. The center frequency of the spectrum analyzer is set to the fundamental frequency and using 1 MHz RBW and 1 MHz VBW, the peak value was measured and recorded.
- 4. Repeat above procedures until all frequencies measured were complete.




The transmitter output was connected to the spectrum analyzer through an attenuator, the bandwidth of the fundamental frequency was measured with the spectrum analyzer using 3kHz RBW and 30kHz VBW, set sweep time = span/3kHz. The power spectral density was measured and recorded.

The sweep time is allowed to be longer than span/3kHz for a full response of the mixer in the spectrum analyzer.



## 4.6.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz and 100 kHz suitable frequency span including 100 MHz bandwidth from band edge. The band edges was measured and recorded.

#### 4.6.6 TEST RESULTS

The spectrum plots are attached on the following 2 images. D1 line indicates the highest level, and D2 line indicates the 20dB offset below D1. It shows compliance with the requirement in part 15.247(d).

#### Note 1:

The band edge emission plot on page 24 shows 30.82dBc between carrier maximum power and local maximum emission in restrict band (2.3248GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 97.92dBuV/m (Peak), so the maximum field strength in restrict band is 97.92-30.82=67.10dBuV/m which is under 74dBuV/m limit.


The band edge emission plot of on page 24 shows 68.46dBc between carrier maximum power and local maximum emission in restrict band (2.3244GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 96.22dBuV/m (Average), so the maximum field strength in restrict band is 96.22-68.46=27.76BuV/m which is under 54dBuV/m limit.



The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 97.92dBuV/m (Peak), so the maximum field strength in restrict band is 97.92-57.40=40.52dBuV/m which is under 74dBuV/m limit.

The band edge emission plot of on page 26 shows 70.86dBc between carrier maximum power and local maximum emission in restrict band (2.4859GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 96.22dBuV/m (Average), so the maximum field strength in restrict band is 96.22-70.86=25.36BuV/m which is under 54dBuV/m limit.
















## 4.7 ANTENNA REQUIREMENT
