
This letter is to inform the FCC that DTC Communications, Inc. failed to respond to the first of two E-mails sent by Mr. Czumak, because the first E-mail was never received. We do know by talking to Mr. Czumak that the lost E-mail was sent approximately two days prior to the E-mail that DTC did respond to.

DTC did not and still does not know what was on the first transmission. We assume that this contains technical questions or comments from Mr. Czumak. DTC is prepared to answer these in a timely fashion.

DTC was concerned about the length of the processing of this application, but in respect to second E-mail content; that is, we thought the FCC was reviewing the SAR laboratory report from PC Test Labs. Subsequently, DTC did have E-mail exchanges with the FCC both about the second E-mail in late July and as late as last month, an inquiry on why the Application had not yet been granted.



1. Please provide spectral plots at the hi and low channel which demonstrate bandedge attenuation compliance.
2. Please provide a copy of the processing gain test data, from the radio manufacturer.
3. Please remeasure the peak output power, with the spectrum analyzer video bandwidth greater than or equal to the resolution bandwidth, and submit results.
4. Please provide the peak field strength levels of the radiated emissions in restricted bands, in order to demonstrate compliance with Section 15.35(b).
5. The user's manual lists 2 antennas- the 11 dBi patch and a 3 dBi omni. Were both tested for radiated emissions? Please submit results for the 2nd antenna.
6. What is the FCC ID of the associated receiver?
7. The potential RF exposure issue is currently under review. Any questions wrt to this issue will be sent to you ASAP.

The items indicated above must be submitted before processing can continue on the above referenced application. Failure to provide the requested information within 60 days of the original e-mail date may result in application dismissal pursuant to Section 2.917(c) and forfeiture of the filing fee pursuant to Section 1.1108
