 $Pd = (Pout*G) / (4*pi*r^2)$

where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

2.3 CLASSIFICATION
