#### 4.5.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer through an attenuator, the bandwidth of the fundamental frequency was measured with the spectrum analyzer using 3kHz RBW and 30kHz VBW, set sweep time=span/3kHz. The power spectral density was measured and recorded.

The sweep time is allowed to be longer than span/3KHz for a full response of the mixer in the spectrum analyzer.

The spectrum plots are attached on the following 2 pages. D2 line indicates the highest level, D1 line indicates the 20dB offset below D2. It shows compliance with the requirement in part 15.247(C).


**NOTE:** The band edge emission plot on the following pages shows 61.22dB / 61.38dB delta between carrier maximum power and local maximum emission in restrict band (2.3877GHz / 2.4844GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.8 is 99.2dBuV/m, so the maximum field strength in restrict band is 99.2-61.22=37.98dBuV/m which is under 54dBuV/m limit.


